

Morehead, Kentucky,  
July 17, 1925.

At a meeting of the Board of Regents of the Morehead State Normal School, held in the office of President Button, at Morehead, Friday, July 17, 1925, at 10:30 A. M., the following members were present:

Mrs. W. J. Fields,  
Sup't McHenry Rhoads,  
Judge Allie W. Young.

The minutes of the last meeting were read and approved.

It was moved by Mr. Rhoads and seconded by Mrs. Fields that the salary of the Business Agent be made \$2,000.00 for the next fiscal year, being the same as the Custodian of Buildings and Grounds. The vote upon this motion was as follows:

It was moved by Young and seconded by Mrs. Fields that the recommendation of the Committee on Face Brick for the Girls' Dormitory be purchased from R. C. Tway & Company, of Louisville, Kentucky, for Hy-tex Mosaic Chinchilla Shale style brick, at \$34.50 per thousand, be approved by the Board. The vote upon this motion was as follows:

On motion of Mrs. Fields, seconded by Rhoads, the action of Young in employing the special supervisor for the Girls' Dormitory was approved by the following resolution:

The appointment of Clyde Miller, having been heretofore appointed by a member of the committee as inspector for the State upon the building now being erected by L. W. Hancock & Company, is now approved and confirmed by the Board, and he is directed to make a report of his acts at the next meeting of this Board, as well as to diligently observe all the material and workmanship used in said building, and see that the same comes up to the plans and specifications made by Joseph and Joseph, Architects. The vote on this resolution was as follows:

It was moved by Rhoads and seconded by Mrs. Fields that a committee be appointed to inspect samples of furniture now in basement of Burgess Hall, and that they are to report their findings and selections with prices attached and reasons for selections at a meeting to be called by the Chairman. It was moved by Rhoads and seconded by Mrs. Fields that A. W. Young be appointed a special committee to obtain bids for piping gas from the wells on Mr. Howard's farm to the Normal School in Morehead; that he shall duly advertise for bids before the same are let; that he shall also obtain from Mr. Howard a contract setting out in full just what rights said school would have, and the price proposed to be paid for said gas, and he will report his acts thereunder to the Board at the next meeting. The vote upon this motion was as follows:

On motion of Young, seconded by Mrs. Fields, Joseph and Joseph, Architects, are instructed to, at once, complete the plans and specifications for the heating plant to be erected on the school grounds of the Morehead State Normal School, and that as soon as they are completed he will, at once, advertise for bids to be opened in the office of the Superintendent of Public Instruction at Frankfort, Kentucky, on Monday, August 10, 1925. All bids must be sent to the Superintendent before ten o'clock A. M. on this day. The vote upon this motion was as follows:

Moved and seconded that the Board authorize the following committee - McHenry Rhoads, A. W. Young and President Button - and appoints them as a special committee on the buildings now in process of erection, including the heating plant to be erected, and also the boulevard or approach and driveways to and through the school grounds, with authority to consider all questions pertaining to same arising between the meetings of the Board, and that they shall report their

actions to the regular meetings of the Board. The vote upon this motion was as follows:

It was moved by Young and seconded by Mrs. Fields that the resignation of Miss Margaret Scott be accepted, and upon recommendation made by President Button, Miss Betty M.
