Bennett absent, and the following business was transacted:

MINUTES: On motion duly made, seconded and carried, the minutes of the meeting of August 24, 1936, were approved and ordered recorded on official minute book of the Board.

BOND COUPONS. The Treasurer then presented to the Board interest coupons Nos. 101-141 inclusive due Apr. 1, 1936 and Oct. 1, 1936, and for \$20.00 each, in re: Docket No. Ky-1060-R, Science Building, which interest coupons matured before bonds were sold and same were delivered to the President with instructions to deliver them, for safe keeping, to the business office.

TIME FXTENSION FOR CONTRACT COMPLETION. On motion of Dr. Taylor, seconded by Mr. Putnam and all members of the Board voting Aye, the following resolution was unanimously adopted, to mit:

EE IT RFSOLVED by the Board of Regents of the Morehead State Teachers College of Morehead, Kentucky, that it hereby request the Federal Emergency Administration of Public Works and the Hon. Geo. H. Sager, Jr., State Director, to extend the date of completion of the contract of the Struck Construction Company, General Contractor, in re: Docket No. Ky-1060R, from December 10, 1936, to April 1, 1937.

TIME EXTENSION FOR CONTRACT COMPLETION. On motion of Dr. Taylor, seconded by Mr. Putnam and all members of the Board voting Aye, the following resolution was unanimously adopted:

BE IT RESOLVED by the Board of Regents of the Morehead State Teachers College of Morehead, Kentucky, that it hereby requests the Federal Emergency Administration of Public Works, and the Hon. Geo. H. Sager, Jr., State Director, to extend the date of completion of the contract of the Struck Construction Company, General Contractor, in re: Docket No. Ky-1192-R, from December 10, 1936, to April 1, 1937.

The Secretary then presented a communication from Messrs. Joseph & Joseph, Architects, of Louisville, Kontucky, of date December 17, 1936, and is in words and figures as follows:

The items still to be adjusted, in our opinion, are protected by the buarantee called for in the specifications.

There are still some Change Orders to be turned over to the P. W. A. office, and we are trying to get these adjusted with the contractors prior to turning them over. However, we see no reason why the Board cannot act upon the acceptance of this work with safety.

Final payment, of course, will not be made until all items are complied with.

ECIENCE EQUIPMENT. On motion of Dr. Taylor, seconded by Mr. Putnam and all members of the Board present voting Aye, the following resolution was unanimously adopted:

"Resolution Re: Docket Kentucky 1060-R Science Building Equipment

We, the Board of Regents, the duly authorized representatives of the Morehead State Teachers College, do hereby accept the bid of Hamilton-Invincible, Incorporated, of Two Rivers, Wisconsin, in the amount of \$24,288.03 for science building equipment to be furnished according to architect's plans and specifications, and direct that the contract be awarded to Hamilton-Invincible, Incorporated".

MHMBER COUNCIL ON HIGHER EDUCATION. On motion of Dr. Taylor, seconded by Mrs. Young and all members of the Poard present voting Aye, except Mr. Putnam not voting, Mr. D. H. Putnam is hereby elected a member of the Council on Public Higher Education in Kentucky, as Board representative of the Morehead State Teachers College.

SIWER RIGHT OF WAY. On motion of Mr. Putnam, seconded by Mrs. Young and all members of the Board present voting Aye, the purchase of sever rights leading from new Dormitory across Proctor-Caudill Land at \$600.00, was approved.
