"This invitational exhibition produced surprising commentaries around the theme of myth and legend," said KFAC curator Adrian Swain. "We were expecting artwork about many local or regional myths. However, the artists took this opportunity to examine national and historical mythologies, pop culture, and religion. It is a fascinating and exciting exhibition."

Myth & Legend opens in conjunction with A Day in the Country Folk Art Show and the Clack Mountain Festival held on Saturday, June 7.

Cooper, Smith to receive 2008 Appalachian Treasure Award

Morehead State University has announced the recipients of the 2008 Appalachian Treasure Award are Calvin Cooper of Fleming County, and Paul David Smith of Pike County.

They will be recognized on Saturday, June 7, at 6:30 p.m. during the Clack Mountain Festival in downtown Morehead.

The Appalachian Treasure Award was initiated in 1988 to honor contributions to the arts and culture of Appalachian Kentucky, including the fields of art, craft, dance, literature, and music. It is sponsored by MSU's Kentucky Folk Art Center (KFAC) and Kentucky Center for Traditional Music.

Cooper took up woodworking following his retirement from the Kentucky Department of Transportation in 1986. His initial work was cut from plywood and painted, but in 1988 he began carving wood found in the forested hills behind his home.

A brightly painted rooster made from a forked branch soon became Cooper's signature piece. Over the years, his work has become a favorite of collectors, and is included in the collections of several museums. A careful inspection of a Cooper's sculpture reveals not only the work of an artist with a fine eye for color and form, but also the work of a consummate craftsman who is dedicated to building objects of lasting significance.

As a boy, Smith became a protégé of the renowned Pike County fiddler Owen "Snake" Chapman. He learned the guitar first, then the mandolin, and by the age of 12, he had mastered the fiddle.

His favorite fiddle was likely made in France more than 200 years ago, and he bought it from a woman in Williamson, W.Va. for \$5.

Smith has played with a number of different bands over the years, most recently with Kentucky Wildhorse. He is a regular at Appalshop events and guest master artist at the Augusta Heritage Center. Smith has won the Ed Haley Memorial Fiddle Fest six times. He has taught numerous workshops at Cowan Creek Mountain Music School, the American Fiddle Tune Festival and at Berea College

Cooper and Smith, as the 2008 Appalachian Treasure award recipients, will join some of the great figures in the cultural history of East Kentucky. Past award winners include Tom T. Hall, Ronald and Jessie Cooper, Loyal Jones, James Still, Gurney Norman, Minnie Adkins and Jean Ritchie.

Other events taking place that day as part of the Clack Mountain Festival include A Day in the Country folk art show, the Appalachian Arts and Crafts Fair, and performances by Ralph Stanley, the SteelDrivers, the Carolina Chocolate Drops and Clack Mountain String Band.

"Gay's position as innovation center director at the enterprise center and the statewide economic development network he works within made him a logical choice to coordinate the business incubator," said Dr. Albert.

MSU President Wayne Andrews appointed an Advisory Committee of area professional and business leaders to assist in the development of incubator policies, the review of business plans and tenant applications, and provide advice to Center tenants on issues and problems related to the growth of their respective businesses.

MSU's College of Business also assigned a full-time small business development consultant to work from the Center. According to Michael Rodriguez, SBDC's business consultant, "we work with prospective, new and existing

businesses. Our objective is to assist businesses, develop and growth. The business does not have to be located in the Enterprise Center to receive our free services and our location in West Liberty is convenient for area clients to visit. We welcome all inquiries."

Dr. Steele to present at Oxford University

Morehead State University's Dr. Paul D. Steele, associate professor of sociology and director of the Center for Justice Studies in the Institute for Regional Analysis and Public Policy, will present a paper, titled "Children in Danger: Civil and Criminal Justice Policies to Protect Children from Sexual Abuse in the United States," at Oxford University in London, England.

Steele has been invited to participate with 25 other scholars from around the world in a think tank to be held from July 27-Aug. 1.

While the group will discuss several types of risk that children face, Dr. Steele's paper will focus on research concerning the prevention of and intervention with child sexual abuse in criminal and civil justice agencies. This presentation expands upon earlier research that was the basis of his testimony before the U.S. Senate's Indian Affairs Subcommittee concerning re-authorization of the

Indian Child Protection and Family Violence Prevention Act in 2006.

After participating in the meetings at Oxford, Dr. Steele will travel to Boston and present a related paper, "Crossing Borders: Contention and Convergence in the Response to Child Sexual Abuse Cases in the Civil and Criminal Justice Systems," at the annual meeting of the Society for the Study of Social Problems on Aug. 2.

He also serves as a member of the advisory board of the Bonnie Eaglin Gateway Children's Advocacy Center in Morehead.

Dr. McCoy receives Phi Kappa Phi grant

Morehead State University's Dr. Janet McCoy, assistant professor of advertising and public relations, has been awarded a 2008 Literacy Grant of \$2,050 by The Honor Society of Phi Kappa Phi.

Dr. McCoy was one of 14 recipients nationwide to receive such an award. Other project partners include Opal Fannin, program specialist for the Morehead State University Adult Learning Center, and Dr. Emma Perkins, associate professor of art and recently-inducted Phi Kappa Phi member.

Fetal ultrasounds to be offered

The Department of Imaging Sciences' Diagnostic Medical Sonography Program at Morehead State University will offer free, two-dimensional fetal ultrasounds to expectant mothers this summer and fall.

The ultrasound examinations will be performed by appointment only on the fourth floor of Reed Hall in the University's sonography lab during Summer II and Fall semesters.

The scans are performed by senior level students who will be directly supervised by associate professor Marcia Cooper. She is certified in obstetrics and gynecology by the American Registry of Diagnostic Medical Sonographers. The fetal ultrasound scans provide students the experience they need for entering into the sonography workforce.

All volunteers will be asked to sign a consent form stating that the scans are "non-diagnostic" and are performed for educational purposes only. Participants are asked to bring a towel and a VHS tape or DVD to record the images, if desired.

Regents extend President Andrews' contract through 2012

Citing "excellence exceeding our expectations" Morehead State University's Board of Regents Thursday rewarded President Wayne D. Andrews with a contract extension, five percent salary increase and MSU's first-ever presidential bonus - \$20,000.

Board Vice Chair Jean Dorton of Paintsville, who chaired the committee which evaluated Dr. Andrews' performance in 2007-08, made the laudatory comments about his leadership in her motion which was approved 8-1.

"I am deeply gratified by the board's action and the positive comments recognizing that the University overcame so many obstacles this school year to emerge with a tolerable budget, a creative tuition plan and a renewed commitment to be the best of the best," Dr. Andrews said after the meeting.

The contract extension carries his appointment through June 30, 2012, and the pay increase raises his annual salary to \$251,160 with an additional five percent of that figure, \$12,558, being contributed to a deferred compensation plan, payable upon retirement.

Dr. Andrews became MSU's 13th president on Jan. 1, 2005. The Regents decided last December to establish a performance bonus as a means of helping retain his services as a successful chief executive. The bonus plan actually allows a maximum of 40 percent of the base salary. This year's bonus represents 8.4 percent of his 2007-08 base.

In other action at the quarterly meeting, the Regents approved a \$122 million operating budget for the 2008-09 academic year, adopted a Code of Ethics for its members and authorized a new tuition model.

The new tuition plan requires students to pay for each course in which they enroll instead of the traditional flat rate for full-time students.

MSU's new budget includes \$1,000 raises for full-time faculty and salaried staff members and a 50-cent per hour increase for full-time hourly staff.

The Regents also recognized former chair James Booth, Dr. Irons and Brian Gay, student regent, for their service to the University.

In other business, the Regents:

- ratified promotions for seven faculty members;
- granted emeritus status to two faculty members;
- reappointed Dean, Dorton and Ford, PSC, as external auditors;
- authorized revisions of the 2008-09 Eagle Student Handbook;
- accepted the gift of 2.3 acres of real estate near St. Claire Regional Medical Center as a future building site;
- approved the disposal of real property through a land exchange with Rowan County Fiscal Court, subject to approval of the Finance and Administration Cabinet;
- confirmed appointment of three new board members of Friends of the Kentucky Folk Art Center, Inc.

The Regents also heard reports on spring 2008 enrollment, gift income, personal service contracts and general receipts revenue bonds.

MSU's unique equine center opens

Morehead State University officially opened its new and unique Equine Health Education Center with a ribboncutting ceremony Thursday at the Derrickson Agricultural Complex on KY 377 north of Morehead.

"This state-of-the-art surgical and medical treatment facility for horses will greatly benefit our veterinary technology, equine science and animal science students as well as regional horse owners," said MSU President Wayne D. Andrews. "It is a major enhancement of our efforts to support the equine industry in Kentucky."

Built at a cost of \$881,000, the facility was financed with a \$550,000 grant from the Kentucky Equine Trust and additional funds from the Kentucky Department of Agriculture and MSU. The grant application was developed by Dr. Judy Willard, associate professor of agriculture, and Dr. Philip Prater, professor of veterinary technology.

The 6,000 square foot building will be dedicated to the training of students in modern equine veterinary technology, including ultrasound, fiber optic endoscopy, surgery, advanced reproductive techniques, intensive care management and digital radiology.

"We are very proud of the fact that we have the only dedicated equine medical and surgical facility in the nation that is associated with a stand-alone veterinary technology program," said Dr. Gerald DeMoss, dean of MSU's College of Science and Technology. "Adding this facility to our livestock and other teaching resources at the agricultural complex will have a very positive impact on our students in all animal science programs."

The facility also is expected to help achieve other goals of MSU's animal-related instructional efforts. Dr. Prater, who works primarily with horses and other large animals, is excited about what the new Equine Health Education Center will do to strengthen MSU's efforts in equine veterinary technology, including the possible addition of a specialty certification in that field of study.

"It is clear that training additional veterinary technicians must be part of the solution to the growing shortage of veterinarians in large animal practice," he stated. "The equine industry offers great opportunities for vet tech professionals."

Dr. Prater is hopeful that MSU's new facility will result in the vet tech program becoming even more attractive to highly-qualified students.

"We already have one of the top programs in the country and this will make us even stronger," he added. "Our students are being prepared to move directly into positions in the most sophisticated veterinary clinics in this country."

Dr. Prater predicts that the new center also will be very helpful to private veterinary medical practitioners in East Kentucky.

"The lives of very valuable and loved horses will be saved because this facility will be so much closer when timely, critical care is needed," he added.

Also involved in the project were Dr. J. Mike Phillips, chair of Department of Agricultural and Human Sciences; Mike Padula, technical consultant to the building project manager; Paula Reynolds, departmental specialist; and Joe Fraley, farm manager.

SIU Edwardsville joins the Ohio Valley Conference

The Ohio Valley Conference announced on Tuesday that Southern Illinois University Edwardsville has been admitted to the Conference and will become the league's 11th member. The move was unanimously approved by the OVC Board of Presidents at their May 30 meeting.

SIU Edwardsville will officially become a member of the OVC on July 1, 2008 while its athletic programs will begin competing in the Conference over the following years as the institution completes its reclassification to Division I. All SIUE team sports will begin regular season competition in the OVC during the 2011-12 academic year and will be eligible for postseason competition in 2012-13. The exception will be the SIUE softball program which will be eligible for both regular season and tournament competition in 2010-11; the softball program was the department's women's sport designee to be fast-tracked to Division I, making it eligible to compete at the Division I level prior to other SIUE sports.

"I am very pleased to welcome SIU Edwardsville as a member of the Ohio Valley Conference," said Dr. Jon A. Steinbrecher, OVC Commissioner. "The addition of SIUE makes us a stronger conference. After our evaluation of the university, it was clear that it is a Division I institution, given the scope and breadth of its academic and athletic offerings. We fully expect SIUE, given its past history and tradition and the commitment they have shown with budgets and facilities, to be very competitive as a Division I institution. The addition also gives us a presence in the St. Louis market, something that is important to our league."

SIU Edwardsville is located in Edwardsville, Ill., which is just northeast of St. Louis, Mo., the 18th largest media market in the United States. The St. Louis metro population includes over 30,000 alumni of Ohio Valley Conference schools, a number that increases to over 70,000 when SIUE alumni numbers are factored in.

"We're glad to welcome SIUE into the OVC family," said Morehead State Director of Intercollegiate Athletics Brian Hutchinson. "This is a move that absolutely strengthens the league and the competitive opportunities for our student athletes. The process has been very forthright and honest in looking into our membership as a whole and SIUE fits exactly what we were looking for."

The University was founded in 1957 and celebrated its 50th year of existence in 2007-08. SIUE sponsors 18 sports (9 men's sports and 9 women's sports) and previously competed as a member of the Division II Great Lakes Valley Conference.

SIUE is currently in the reclassification process to Division I, as the program completed its one-year exploratory period in 2007-08. SIU Edwardsville will compete against a Division I schedule beginning in 2008-09 and will conclude the reclassification process in the 2011-12 season. SIUE will become a full Division I program beginning in the 2012-13 season.

With nearly 13,500 students, SIUE is ranked among U.S. News & World Report's Top 10 public master's level universities in the Midwest region. For three years in a row, *U.S. News* has named SIUE among "America's Best Colleges" for its Senior Assignment Program; the program was also recognized in 2007 as a national model for learning assessment by the Association of American Colleges & Universities.

The University offers undergraduate and graduate degrees in arts and sciences, business, education, engineering and nursing as well as professional degrees in pharmacy and dentistry. The School of Dental Medicine is ranked among the best in the nation.

"During the 12 years I was at Murray State University, I was impressed by the high level of OVC competition and great rivalries," said Dr. Vaughn Vandegrift, SIUE Chancellor. "We are most pleased to be joining this association of quality universities."

The Ohio Valley Conference is expanding for the first time since 2003 when it added two institutions, including current member Jacksonville State.

The OVC was established in 1948 and is the eighth-oldest Division I conference. With the addition of SIU Edwardsville, the OVC will include 11 teams from five states. The current members of the OVC are: MSU, Austin Peay State University (Clarksville, Tenn.), Eastern Illinois University (Charleston, Ill.), Eastern Kentucky University (Richmond, Ky.), Jacksonville State University (Jacksonville, Ala.), Murray State University (Murray, Ky.), Southeast Missouri State University (Cape Girardeau, Mo.), Tennessee State University (Nashville, Tenn.), Tennessee Technological University (Cookeville, Tenn.) and University of Tennessee at Martin (Martin, Tenn.).

The OVC currently sponsors championships in 18 sports: baseball, men's and women's basketball, men's and women's cross country, football, men's and women's golf, rifle, women's soccer, softball, men's and women's tennis, men's and women's indoor track & field, men's and women's outdoor track & field and volleyball.

Dogwood Technologies another successful business aided by the REC

Dogwood Technologies LLC is a software company founded in November 2007 by CEO and owner Mike Bryant to provide software consulting to a wide variety of clients across the United States.

"Providing software consulting services around the U.S., which allows you to provide quality work at much lower prices than metropolitan areas," said Bryant.

Bryant, a serial entrepreneur, previously owned Centrant LLC, a software company that had developed a product called PHP Jumpstart, a code generation software tool. He sold Centrant in July 2007 for more than \$600,000 and immediately began working to create his new company.

Since founding this new venture, Dogwood is on track to generate nearly \$150,000 in revenue in its first year. Bryant believes it's possible to grow his company's revenues by nearly 50 percent in his second year of operation. In addition to Bryant's own work, he also employs five software developers in the community. These contract employees are expected to generate payroll of nearly \$50,000 in its first year.

"When you consider that this payroll is for men who're already gainfully employed in the community and that this is their 'evening job', this is a significant boost in our community," said Bryant.

In the future he hopes to double his payroll as well and to bring some of this talent on board as full time employees. Over the long term, he believes it is possible to grow his company to a million dollar venture.

In addition to his work at Dogwood Technologies, Bryant was recently named CEO of BAT Medical Networks, a company that's attempting to provide IT hardware that will allow hospitals to share medical records. He thinks it's possible to grow BAT to more than a \$10 million venture over the next few years if all goes according to plan. This is his second executive posting, as he previously worked for the company that purchased Centrant as a vice president.

Johnathan Gay, the director of Morehead State University's Innovation Center says Bryant typifies what is possible in a rural area.

"If I could dream up an economic development strategy for the mountains that would be certain to work it would consist of cloning multiple Mike Bryants. Mike's entrepreneurial savvy and IT skills are an incredible combination. And the fact that they're in Jackson means that the money they generate goes much farther than it would in more urban areas."

MSPR donates weather alert radios to Elliott County

Morehead State Public Radio is distributing 50 Midland AM/FM Weather Alert Radios to 18 primary counties that includes Bath, Breathitt, Carter, Elliott, Estill, Fleming, Lee, Lewis, Martin, Mason, Menifee, Montgomery, Morgan, Nicholas, Owsley, Powell, Rowan and Wolfe counties.

The radios are being presented to public officials and placed in public buildings such as schools, health clinics, libraries and first responder facilities. MSPR also will distribute informational brochures on emergency preparedness from the Ready America project provided by the Federal Emergency Management Association (FEMA).

The radios utilize Specific Area Message Encoding (S.A.M.E.) technology, which allows the radios to be programmed to receive only those warnings that apply to local counties. Operated by AC or emergency battery, the radios can be programmed for up to 30 counties and features AM/FM tuning, color coded alert lights and several alarm functions.

MSPR purchased the radios through a Rural Listener Access Incentive Grant from the Corporation for Public Broadcasting.

Rural Physician Leadership Track program announced

Morehead State University, St. Claire Regional Medical Center and the University of Kentucky Tuesday announced a new program through the UK's College of Medicine which aims to recruit, train and retain future physicians in the state's medical underserved rural areas through the creation of regional medical school sites at Morehead and Murray.

"The prospect of training medical students in our joint health education facility is very exciting," said MSU President Wayne D. Andrews. "This decision by UK will have a far reaching, positive impact on East Kentucky's health care future."

Morehead's site is scheduled to open in 2010 and Murray's in 2012.

The Rural Physician Leadership Track is part of a plan by the College of Medicine to increase class size by nearly 30 percent over the next several years. Ten students will be recruited for the program each year in 2008 and 2009, raising first-year enrollment from 103 to 113.

After completing their first two years of medical school at UK's main campus, students will spend their third and fourth years at the Morehead site, which will work in cooperation with St. Claire Regional Medical Center to provide hands-on medical training.

With the addition to the new program, a new \$28 million health sciences building near Second Street will be constructed. The 92,500-square foot facility will house MSU's departments of nursing and imaging sciences, UK's physician assistant and family nurse practitioner programs, in addition to a freestanding primary care clinic, and comprehensive health education center.

"This three-way partnership makes sense for the taxpayers of Kentucky and for each of our respective institutions. We (MSU) needed more space for educating health care professionals and St. Claire needed more space for diagnosing and treating patients," said Dr. Andrews.

"Today's announcement is the icing on the cake. A regional site of the U-K College of Medicine that is dedicated to training rural physicians will literally change the face of medical education in this state and bring even greater credibility and prestige to health sciences programs at Morehead State."

The clinic will serve as the primary training site for the SCR/UK family practice residency program and will include examination rooms, a dental suite, as well as provide for a clinical laboratory and basic radiology services.

The comprehensive health education center will be designed to accommodate a wide range of continuing education/workshop programs, teleconferencing and telemedicine initiatives, specialized professional development/enrichment opportunities for health-care providers, and rural health research activities.

The space for MSU's departments of nursing and imaging sciences would include lecture and laboratory classrooms to support the associate and baccalaureate degree nursing programs, the radiologic technology program, and the sonography, computed tomography, and magnetic resonance program options. Also included would be faculty/staff offices and conference areas.

Additionally, space will be provided for anticipated growth in these programs and the planned implementation of MSU's new master's degrees in nursing and in nuclear medicine. Similar space will be available to support UK's master's-level programs for physician assistant and family nurse practitioner.

Groundbreaking is scheduled for later this summer.
