

At a meeting of the Board of Regents of the Morehead State Normal School and Teachers College held pursuant to call, at the Administration Building, Morehead, Kentucky, September 10th, 1929, Mrs. S. M. Bradley, Vice Chairman, Judge Allie W. Young, Mr. Glenn E. Perry, and Secretary E. W. Senff were present, and the following business was transacted:

The minutes of the last meeting, a copy of which was furnished each member of the board, were on motion duly carried approved and ordered recorded.

Bids for the erection of the proposed new library, the plumbing, electric wiring and heating were then opened publicly before the bidders and read aloud, and after a comparison and careful consideration of all of said bids, on motion of Judge Young, seconded by Mr. Perry and all members of the Board present voting Aye, the lowest bid in each instance was accepted, to-wit:

J. J. & T. J. Murphy, Bowling Green, Kentucky, on general contract \$137,763.00, using Bowling Green stone, and taking credit of \$1500.00 on beams item;

Grant Witt & Son, Winchester, Kentucky, plumbing, \$2690.00, plus \$353.00 for hot water and \$545.00 for cooling system;

Electric Wiring & Contracting Company, Winchester, Kentucky, electric wiring \$3367.00, plus \$15.00 on refrigeration item;

Ben F. Hurst, Richmond, Kentucky, heating \$5347.50, and the architects, Joseph & Joseph were ordered and directed to prepare and execute contract with each of the above named and take appropriate bond as per terms of bidding. Said architects were also ordered and directed to return the certified drafts and checks to all unsuccessful bidders and to successful bidders upon execution of contract and bond.

On motion of Judge Young, seconded by Mr. Perry and all members of the Board present voting Aye, the face brick to be used shall be selected by the Board.

On motion, duly carried, Mrs. S. M. Bradley, Mrs. J. H. Payne, Mr. Glenn E. Perry and Secretary Senff were appointed a committee to decorate new President's Home and furnish the first floor of same, with power to act in the premises.

On motion of Mr. Perry, seconded by Judge Young, a leave of absence is granted Miss Judith Johnson to July 1, 1930.

On motion of Judge Young, seconded by Mr. Perry, the Treasurer is authorized to take such steps as may be necessary to secure duplicate check from the State, in lieu of one alleged to have been mailed and lost in transit, or

to collect the sum due in any manner authorized by law.

On motion of Judge Young, seconded by Mr. Perry and all members of the Board **present** voting Aye, each member of the Board is given authority to designate four worthy persons for scholarships and the President is given authority to name such additional ones as may be necessary to properly conduct the institution.

It appearing that the new President, John Howard Payne, had devoted the month of August in the selection of a new faculty, as directed by the Board at its last meeting, on motion of Judge Young, seconded by Mr. Perry and all members of the Board voting Aye, the Treasurer is authorized and directed to pay said Payne for said month of August at the salary rate heretofore fixed, to-wit \$5000.00 per annum.

President Payne then submitted list of faculty members and employes and recommended its adoption and after a careful consideration of same and making several salary changes, said list was approved and is as follows:
