

At a meeting of the Board of Regents of the Morehead State Normal School and Teachers College, held at the office of the chairman, Professor W. C. Bell, at Frankfort, Kentucky, on January 10th, 1930 at which meeting Mrs. S. M. Bradley, Professor W. C. Bell, Judge Allie W. Young, Mr. Glenn E. Perry and Secretary E. W. Senff were present, and the following business was transacted, to wit:

On motion duly carried minutes of last meeting were read and approved.

Bids for brick for library building were then opened and are as follows:

#6 Canton Buff-Smooth @ \$35.00 (for inside)  
#3 Stone Creek Mingle @ \$30.00 (for outside)

The above prices being f. o. b. Morehead, Kentucky.

The above bid being submitted by the Clay-Ingels Company of Lexington, Kentucky.

On motion duly carried the bid of P. H. Meyer Company is changed to the extent that self-closing faucets are to be used at the additional sum of \$59.00, and the bid of the Art Metal Company of \$1973.69 in connection with proposed post office was accepted.

On motion of Judge Young, seconded by Mr. Perry, and all members of the Board voting aye, the report of R. G. Kern, showing audit of Treasurer's account for one year was approved and ordered spread at large upon the minute book. The report is as follows:

As per your request I have audited the accounts of E. W. Senff as Treasurer of the Morehead State Normal School and Teachers College from the first day of August 1928, (the date of his election), to July 31st, 1929, and beg to advise you as follows:

The Auditor's office also reported check of Mrs. Emma Guy Cromwell, State Treasurer, of date June 5, 1929, and for millage and for \$9468.38 having been sent the Treasurer. This check was lost in the mails and duplicate check, upon request of the Board of Regents was not issued until long after July 31, 1929 and is therefore not taken into account in this settlement.

CITIZENS BANK OF MOREHEAD

At the time of the closing of the Morehead State Bank in July 1928, Mr. S. M. Bradley, former Treasurer, had to his credit in said bank, \$132,103.17

The affairs of the Morehead State Bank were taken over by the Citizens Bank of Morehead. This fund cannot be checked out except gradually and then only by permission of the State Banking Commissioner and the present Treasurer is only chargeable with it as he is able to actually withdraw it. The Morehead State Bank is to pay 3% on the average daily balance, and I am charging the present Treasurer with the sum actually withdrawn by him and state said account to be as follows:

per thousand were accepted.

On motion of Secretary Senff, seconded by Mr. Perry and  
all members of the Board present voting aye, the recommendation  
of the president and dean that certificates be extended for life  
to John Gray, Laura Steele and Esther L. McGuire was approved.

Professor J. L. Chambers appearing before the Board and replying at length to the statements contained in the report of the committee heretofore appointed to investigate his conduct while dean of the Morehead State Teachers College and the Board desiring to further investigate the facts, said Chambers is requested to reduce his oral statements to writing, which request was communicated to said Chambers by the Secretary, and which request said Chambers declined to comply with.

On motion of Secretary Senff, seconded by Mr. Perry the treasurer is authorized and directed to sign and mail check for \$40.00 to Mrs. J. L. Chambers in full of her services and upon a roll call all members of the Board voted Aye, except Judge Young not voting.

It appearing that in the construction of the Training School it will be necessary to remove a small residence now on the lot, the President is directed to see that said house is so moved.

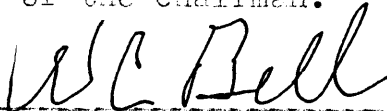

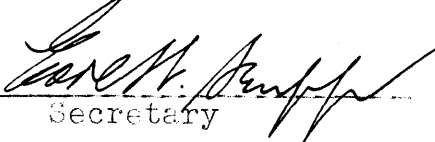
