At a meeting of the Board of Regents of the Morehead State Teachers College, held July 17, 1931, pursuant to call, at the Administration building in Morehead, Kentucky, Professor W. C. Bell, chairman, Mrs. S. M. Bradley, Dr. J. M. Rose, and Mr. W. A. Stanfill and Judge Allie W. Young were present, and the following business was transacted, to-wit:

Mr. Stanfill moved that the following paragraph from the minutes of the last meeting be set aside and expunged from the records of the Board, to-wit:

"Judge Young then moved that Hon. Edward C. O'Rear, attorney at law, Frankfort, Ky. be instructed to institute proper proceedings against S. M. Bradley, former Treasurer, to recover from him all interest due the institution, which motion was seconded by Mr. Stanfill and upon a roll call all members of the Board present voted Aye, except Dr. Rose voting present, and said motion is now declared duly adopted."

which motion is seconded by Dr. Rose, and upon a roll call, all members of the Board voted Aye, except Judge Young voting no, and said motion is declared adopted and the paragraph above quoted is now expunged from the official minuted book of the Board, and said minutes as corrected are now approved.

The secretary then reported that as directed by the Board, he had requested the city of Morehead to take steps at once to prevent, if possible, a re-occurrence in 1931 of the water shortage of 1930, and submitted to the Board the following from the Mayor of Morehead, to-wit:

"Morehead, Kentucky June 15, 1931

Judge Earl W. Senff, Mt. Sterling, Kentucky

Dear Judge:

I have your letter of the 10th, concerning the water supply. We have employed an engineer to make a survey, and he will begin his work today. As soon as he makes his report, we will get busy, and do everything possible to prevent another water shortage such as we had last year. I desire to thank you and the Board of Regents through you for your interest in this matter.

(Signed) H. L. Wilson, Mayor City of Morehead" The secretary then presented to the Board report of R. G. Kern, Accountant, covering his audit of the books and accounts of the Treasurer to July 1, 1931, as well as his report of his audit of the account at the Citizens Bank, and on motion of Judge Young, seconded by Mr. Stanfill and all members of the Board voting Aye, the secretary is ordered and directed to furnish copies of such records to each member of the Board, and this subject will lie over until the next meeting of the Board for further action thereon.

The committee heretofore appointed to investigate the high school credits of Mrs. Mallie D. Wells presented to the Board the following report, to-wit:

"June Twenty-nine 1931

The Board of Regents, Morehead State Teachers College, and Mr. W. C. Bell, State Superintendent of Public Instruction:

Gentlemen:

Pursuant to a resolution of your Board, caused to be investigated the high school credits of Mrs. Mallie D. Wells, Mt. Sterling, Kentucky, that are now on file in this Institution, I submit the following report of this investigation:

- 1. The high school credits of Mrs. Mallie D. Wells were accepted on a statement of Mr. Lenix Swango, a teacher in Hazel Green Academy for the school years 1908-1910, supported by an affidavit from Mrs. Wells. This manner of acceptance was agreed to because the records of Hazel Green Academy had been burned.
- 2. Through an affidavit, Mrs. W. G. Marshall, Mt. Sterling, Ky., said she had reason to doubt the validity of Mrs. Wells statements, and asked the privilege of submitting evidences to sustain her contention. Mrs. Marshall submitted six of the annual catalogues of the Hazel Green Academy for the period 1900-1909, and a statement of Mrs. Rose Coldiron Conlee for the other two annual catalogues of this period. These catalogues were supposed to contain the names of all students for the year, and the graduates of the academy. In none of these, did there appear the name of Miss Mallie Deaton (the maiden name of Mrs. Mallie D. Wells) Nor Mrs. Mallie D. Wells. She further furnished the names of Mrs. Rose Conlee, Mrs. India Center and Mr. Carl Mize of XXX Hazel Green as persons who were competent to testify in this matter. She further submitted an affidavit from Mrs. W. E. Keath, a student at Hazel Green during this period, to the effect that Mrs. Wells was not known to her as a student.

Mrs. Marshall also submitted a copy of a record Mrs. Wells had filed some years ago in the office of City Superintendent, H. A. Babb, that shows a materially different statement of her high school record to the one covered by the affidavit submitted by Mrs. Wells in connection with her credits here at the College. Superintendent Babb personally told the Committee, that the copy submitted by Mrs. Marshall was a true copy.

- 3. As Registrar of the Morehead State Teachers College, I called to my assistance, in making this investigation, the usual advisory committee in matters of certificates and credits. This Committee consists of: Professor Warren Lappin, Chairman, Acting-Dean Henry C. Haggan, Professor E. V. Hollis and Mary Page Milton, Registrar. At a meeting of this Committee on June 10, 1931, the evidence of paragraph number 2 was submitted. Mrs. Wa G. Marshall was given a personal hearing at this meeting, and immediately following this, Mrs. Wells, accompanied by her attorney, the Hon. W. C. Hamilton, was given a hearing.
- 4. At the above hearing, Mrs. Wells indicated her intention to support the veracity of her affidavit and the statement of Lenix Swango. Mrs. Wells stated to the Committee that she had done parts of her high school work at Louisa under Professor Byington and at Maytown under Professor Taulbee. Since neither of these schools were accredited, she later took qualifying examination on the work, and the work she had previously done at Hazel Green Academy, under Mr. Lenix Swango. Mrs. Wells claimed to have been a regularly enrolled student at Hazel Green Academy when Mr. Derthick was Principal (he was principal only for the year 1907-08). She further states that she was not a regularly enrolled student when she took the qualifying examinations that were being given the regular graduating class. She could not remember the dates or years in which she was a student at Hazel Green. The only date that she was able to give was the one in her affidavit, that the work was previous to the year 1909.
- 5. Through her attorney, Mr. W. C. Hamilton, Mrs. Wells asked for an extension of time in which to submit evidence of her credits from Hazel Green Academy. She was granted a ten day extension of time.
- 6. The Committee investigating this case decided to send one of its members to Hazel Green and intermediate points to investigate the matter first hand. Professor E. V. Hollis was designated for this duty. He made a trip to Hazel Green, examined a complete file of catalogues from 1900-1910, and did not find that Mrs. Wells had been listed in any of these catalogues as a student. He interviewed Miss Nancy Maples, now, and for many years connected with the school, and she says that she was away from Hazel Green from 1900 to 1906, but that since 1906 she has been there. She has no personal recollection of

Mrs. Wells as a student. She says that in 1906 Mr. Lenix Swango was a student with her in the school, and that he never did finish high school there or elsewhere. The catalogues of the school show Mr. Swango as teacher of Business for the school year 1908-09, and teacher of the sixth grade in 1909-10. Professor Hollis interviewed a number of the residents of the Hazel Green community who were students or lived in the community during the years in question, and did not find any substantial evidence of Mrs. Mallie D. Wells student connection with the school. Among the persons interviewed were: Mrs. Rose Coldiron Conlee, Mrs. India Center, Mr. Carl Mize, and Mr. Troy Pieratt, now of Stanton, Kentucky. Only Mrs. Center and Mr. Pieratt remembered Mrs. Wells. Mrs. Center said she was in a teachers' review course in the year 1906. Mrs. Wells was remembered as a visitor to Hazel Green in the home of Mr. Lenix Swango who had married her step-daughter. Professor Hollis was given the name of Mr. C. E. Clark, now an attorney in Chicago, Illinois, who was competent to speak on the subject of this investigation. Mr. Swango's statement and Mrs. Wells affidavit claim for her one unit of credit each in the following subjects: Frency, Chemistry, and Sewing. Professor Hollis examined the catalogues of the entire period, and failed to find either of these three subjects offered by Hazel Green Academy.

In her statement to the Committee, Mrs. Wells said that Mr. C. E. Clark of Chicago would be able to substantiate her claims. She filed with the Committee a telegram and a statement (not of the letterhead of Mr. Clark) from Mr. Clark concerning her work at Hazel Green. The Committee wrote Mr. Clark and later sent him a telegram inviting him to furnish the Committee any information he might have bearing on the He was asked to submit it in the form of an affidavit. date he has not replied. The Hon. W. C. Hamilton submitted for Mrs. Wells an affidavit from Mr. H. J. Derthick concerning her work at Hazel Green. The Committee had wired Mr. Derthick to submit to it such an affidavit. A copy of this affidavit is attached herewith. In brief, it states that it was his "understanding" that said Mrs. Wells was a student in said academy and met all the requirements and completed the high school work as given by said institution without any conditions". Since this affidavit claims more for Mrs. Wells that she herself claims, and since it is made only on "the understandings" the Committee felt that it had little weight.

In view of the findings as above set out, it is the recommendation of this investigating committee and of the Registrar that this College should not further accept as valid the high school credits now on file with the Registrar of the Morehead State Teachers College in the name of Mrs. Mallie D. Wells.

Sterling, Kentucky, a former student in Hazel Green Academy; that it is affiant's understanding that the records of said institution were destroyed or lost, arising from the destruction of said property by fire, but that said Mrs. Wells was a student in said academy and met all the requirements and completed the High School work as given by said institution without any conditions.

Said committee also filed with the Board a letter, statement and affidavit later received from Mr. C. E. Clark, witness for said Mrs. Wells and Mr. W. C. Hamilton, her attorney appeared before the Board and orally discussed the issues involved, and at the same time filed with each member of the Board an additional statement for and on behalf of said Mrs. Wells.

After a general discussion of the matter, Judge Young moved that the report of the committee be adopted, effective in ten days from date, which motion receiving no second was declared lost.

Mr. Stanfill then moved that the report of said committee be rejected, and the credits of said Mrs. Mallie D. Wells be accepted, which motion was seconded by Dr. Rose and upon a roll call, Mrs. Bradley, Mr. Stanfill and Dr. Rose voted Aye, and Professor Bell and Judge Young voted No, and said motion was declared adopted.

The Certificates Committee then filed with the Board the following report relative to application of Mr. R. A. Wireman for the life-renewal of his Standard Certificate, towit:

"CERTIFICATES COMMITTEE June 16, 1931

Members Present: Mr. Haggan, Mr. Lappin, Mr. Hollis, Miss Milton.

The Certificates Committee voted to recommend that the application of R. A. Wireman for the life-renewal of his Standard Certificate be refused because of certain irregularities in the issuance of the original certificate. These are:

Mr. Wireman was issued the Standard Certificate under date of September 1, 1928, abthough at that time he had not satisfactorily met College Entrance requirements according to the records in the office of the Registrar of the College and according to records on file in the State Department of Education.

The date of High School graduation claimed by Mr. Wireman differs in the records of the State Department and in the records here at Morehead.

The facts are not clear as to just how his High School work was done. The claim is made that certain high school credits were transferred from Louisa (Ky. Normal College) to Salyersville (Magoffin Baptist Institute), but upon what basis this transfer was made, has not been definitely established.

Before completing his High School course, Mr. Wireman claims to have done a considerable amount of College work. This practice is also irregular.

Mr. Wireman's Standard Certificate (the original issuance) was not recommended by the Committee on Certification, in fact, it was probably never brought before the Committee, but was presented directly to the Board of Regents.

The transcript of credits upon which the Certificate was issued, is an unsigned transcript, and is therefore unofficial.

On motion of Judge Young, seconded by Mr. Stanfill and all members of the Board voting Aye, except Dr. Rose voting present, such report was approved.

Pelfrey for the ensuing term of one year, at a salary of \$100.00 per month, and udge Young moved that such recommendation be concurred in, which motion was seconded by Dr. Drose, and upon a roll call all members of the Board voted Aye, and said motion was declared adopted.

The President then placed in nomination for the position of Janitor at the Library building, Mr. Wm. G. Davis for the ensuing term of one year, at a salary of \$100.00 per month, and Judge Young moved that such recommendation be concurred in, which motion was seconded by Dr. Rose and upon a roll call all members of the Board voted Aye, and said motion was declared adopted.

The President then placed in nomination for the position of Custodian of the Bookstore, Miss Avanelle Bradley, for the ensuing term of one year, and at a salary of \$100.00 permonth, and Judge Young moved that such recommendation be concurred in, which motion receiving no second, was declared lost.

The President then placed in nomination for the position of Night Watchman, Mr. Frank Robinson, for the ensuing term of one year, at a salary of \$100.00 per month, and Judge Young moved that such recommendation be concurred in, which motion was seconded by Dr. Rose, and upon a roll call all members of the Board voted Aye, and said motion was declared adopted.

The President then placed in nomination for the position of Carpenter Mr. Stonewall Jackson for the ensuing term of one year, and at a salary of \$125.00 per month, and Judge Young moved that such recommendation be concurred in, which motion was seconded by Mrs. Bradley, and upon a roll call, all members of the Board voted Aye, and said motion was declared adopted.

The President then placed in nomination for the position of stenographer, Miss Lula Thomas, for the ensuing term of one year, at a salary of \$85.00 per month, and Judge Young moved that such recommendation be concurred in, which motion was seconded by Mrs. Bradley, and upon a roll call all members of the Board voted Aye, and said motion was declared adopted.

Mrs. Bradley moved that the school physician be authorized to employ a nurse at a salary not exceeding that now paid, and Judge Young moved as a substitute that the said physician be authorized to make such employment, subject to the approval of the President, which substitute received no second, and was declared lost, and Dr. Rose then seconded the motion of Mrs. Bradley, and upon a roll call all members of the Board voted Aye, except Judge Young voting No, and said motion was declared adopted, and the point of order being raised by President Payne that the motion as adopted is violative of the rules heretofore adopted for the government of the college, which point of order the chair did not rule upon, but after a general discussion of the intention of the Board by its action, Chairman Bell announced that it was the purpose of the Board to permit such physician to make such employment, subject to the approval of the President.

The newly elected chef, Mr. D. J. Gammage, then appeared before the Board, and was heard regarding the advisability of electrifying the kitchen, as was also Mr. B. E. Waltz, General Manager of the Kentucky Power Company, who filed with the Board a statement showing the special schedule of rates that would be given the college in the event said kitchen was electrified, which statement is as follows:

"Maysville, Kentucky June 30, 1931 President J. Howard Payne, Morehead State Normal School, Morehead, Kentucky

Dear Sir:

Some time ago when in Morehead you raised the question of what rate we might be in position to quote providing you electrified your cafeteria. At that time you referred to the Wilmore rate.

In order to have before you clearly our Morehead charges to the State Normal, and that which has been made to the college at Wilmore, we attach hereto a table showing the KWH consumption of the Morehead State Normal by months during the year 1930:

You will note that we have used an "estimated" 90 KW demand. We have done this because the Wilmore rate is based on a \$2.00 per KW of demand charge, plus the following energy charges:

You will note on the attached sheet that there is a column marked "Present", which is as we are now charging the Morehead State Normal. One column is marked "Wilmore" which would be the cost to the Morehead State Normal had the Wilmore rate applied. A third column we have marked "Proposed" which would be approximately the charges if this proposed rate had been in effect during 1930. The "proposed rate" is submitted entirely on the basis and assumption that you are going to electrify your cafeteria and would apply just as so on as you have purchased sufficient cafeteria equipment to indicate that you are going ahead with this work.

The basis upon which the "proposed" Column is figured is indicated in a proposed schedule shown on the bottom of the sheet.

Judge Young then moved that the chair appoint a committee to take up said subject, as well as the advisability of enlarging the cafeteria, with power to act in the premises, which motion was seconded by Mrs. Bradley, and upon a roll call, all members of the Board voted Aye, and said motion was declared adopted, and the chair designated upon said committee, President Payne, Mrs. Bradley, Dr. Rose and Mr. Gammage.

Mrs. Bradley then moved that the chair appoint a committee to investigate the advisability of hereafter conduting the bookstore wpon a commission basis, which motion was seconded by Judge Young, and upon a roll call all members of the Board voted Aye, and said motion was declared adopted, and the chair appointed upon said committee President Payne, Mrs. Bradley and Judge Young.

No action having been taken upon the recommendations of the President for the positions now held by Mr. Blair, Mr. Lane and Miss Bradley, the President is given further time in which to make additional recommendations.

The resignation of Mr. H. C. Haggan, as Dean of Men, was presented, and on motion duly carried, was accepted and the president then placed in nomination for the position of Dean of Men, Mrs. Martha Blessing, for the ensuing term of one year, and at an added salary of \$400.00, making \$2800.00 per year, and Judge Young moved that such recommendation be concurred in, which motion was seconded by Dr. Rose, and upon a roll call all members of the Board voted Aye, and said motion was declared adopted.

President Payne then placed Miss Catherine Riggs in nomination for the position of head of physical education, Vice Mrs. Lucy Lane, resigned, for the ensuing term of one year, and at a salary of \$2500.00 per year, and Judge Young moved that such recommendation be concurred in, which motion was seconded by Dr. Rose, and upon a roll call, all members of the Board voted Aye and said motion was declared adopted.

Judge Young then moved that the chair designate a committee to ascertain if the Worley Hall property, adjoining the campus, can be acquired at a reasonable price, and report back to the Board, which motion was seconded by Dr. Rose, and upon a roll call all members of the Board voted Aye, and said motion was declared adopted, and the chair designated on such committee Dr. Rose, Mrs. Bradley, and Judge Young.

Judge Young moved that each member of the Board be allowed to select four worthy persons for scholarships for the semester beginning in September, and Mr. Stanfill moved as a substitute that such number be increased to six, which substitute motion was seconded by Judge Young, and upon a roll call all members of the Board voted Aye, except Professor Bell voting no, and said motion was declared adopted.

There being no further business, on motion, duly carried, the meeting adjourned to meet at ten o'clock A. M.
