At a meeting of the Board of Regents of the Morehead State Teachers College, held at the Administration Building, Morehead, Kentucky, pursuant to call, on Thursday, April 12, 1934, Dr. J. H. Richmond, Superintendent of Public Instruction and exoffice chairman, Judge D. B. Caudill, Dr. J. M. Rose, Judge Allie W. Young and Secretary Earl W. Senff were present, and the following business was transacted, to-wit:

Dr. J. M. Rose presented his certificate showing his reappointment as a member of the Board of Regents for the term of four years beginning April 1, 1934, together with a certificate showing he had been sworn as required by law by Albert J. Counts, Notary Public of Carter County, Kentucky.

Judge D. B. Caudill also presented his certificate showing his appointment for a like term, as a member of the Board of Regents, to succeed Hon. W. A. Stanfill and said Caudill was then duly sworn, as required by law, by Miss Anna B. Carter, Notary Public of Rowan County, Kentucky.

The minutes of the last meeting of date Dec. 9, 1933, were then read, and on motion of Judge Young, seconded by Secretary Senff, same were approved and ordered recorded on the official minute book of the board, all members of the board voting Aye, except Judge Caudill voting present.

The committee appointed at the last meeting composed of Dr. J. H. Richmond and Secretary Senff reported the execution of contracts with President Payne and Treasurer G. E. Senff as per direction of the Board.

"This contract made and entered into this March 20, 1930, by and between the Board of Regents of the Morehead State Normal School and Teachers College of the first part, and John Howard Payne, of Morehead, Kentucky, of the second part, WITNESSETH:

That at a meeting of the Board of Regents this day held, the said John Howard Payne was unanimously elected President of the Morehead State Normal School and Teachers College for a full term of four calendar years, and his compensation for the services to be rendered as such President was fixed at the sum of Five thousand (\$5,000.00) Dollars per year, payable in twelve equal monthly instalments at the end of each and every month; and the said Board of Regents agrees to furnish and maintain a residence upon the campus of the Morehead State Normal School and Teachers College at Morehead, Kentucky, for the occupancy of the said John Howard Payne as President of said institution, and to furnish heat, water and light free of charge to the said John Howard Payne as President of said institution. The said John Howard Payne accepts said appointment and election as President of the Morehead State Normal School and Teachers College for the said term of four years for the above compensation and remuneration for the services to be rendered by him as such President.

Based upon said election, compensation, remuneration and salary for the said term of four years, the said John Howard Payne agrees and contracts with the said Board of Regents to serve as President of said institution upon said terms and conditions for the said term, and to render efficient service in said educational institution under the charge, direction and management of said Board.

By order of the Board of Regents, this contract and agreement is this day entered into for andon behalf of the said Board of Regents, and the Chairman and Secretary of said Board, under the direction and order of said Board, sign, execute and deliver said contract and agreement to the said John Howard Payne, and he signs and accepts said agreement for and on behalf of himself individually.

It is further agreed and directed by and between the parties hereto and in consideration of this contract, that if the said John Howard Payne at any time within the said period of four years desires to relinquish said position and resign from the duties devolving upon him as such President, that he will, before tendering said resignation, advise the said Board in writing for not less than three months previous to the date that said resignation shall become effective.

Upon the statement of the Registrar that he had met all the requirements, it was voted to recommend to the Board of Regents the issuance of a Standard certificate to <u>Herbert Howard</u>.

The Committee voted to recommend the life extension of a Standard certificate for <u>Miss Iva Jessee</u> as soon as an additional statement was received from the county superintendent giving the specific dates of teaching.

Dean Vaughan asked the opinion of the Committee in the case of  $\frac{W. L. Stallard}{1/2}$  who had no Psychology in College but had had 1/2 unit in High School. The committee agreed that this would substitute.

On motion of Judge Young, seconded by Dr. Rose and all members of the board, on roll call, voting Aye, the committee heretofore authorized to apply for gift and loan from Federal Emergency Administration of Public Works was authorized and directed to amend application heretofore filed in accordance with the provisions of House Bill No. 639 recently adopted by the General Assembly of Kentucky and to signify the willingness of the Board to execute bonds evidencing such loan, in accordance with said law.

It appearing the college now owns a water heater for which it has no present use, on motion of Judge Young, seconded by Judge Caudill and all members of the Board voting Aye, on roll call, the President is authorized to sell the same upon the best terms he can obtain.

After a general discussion of the condition of certain trees on the campus, Dr. Richmond moved that not exceeding \$200.00 be tentatively appropriated for their treatment and that same be expended by the President, after he shall have availed himself of the advice and assistance of the proper department the University of Kentucky, which motion was seconded by Dr. Rose and on a roll callall members of the board voted Aye.

On motion of Judge Caudill, seconded by Judge Young and all members of the board voting Aye, upon a roll call, the recommendation of the President that another mowing machine costing approximately \$195.00 be purchased, was approved and concurred in by the board.

On motion of Judge Caudill, seconded by Judge young and all members of the board voting Aye, upon roll call, the Superintendent of Buildings and Grounds was authorized to expend not exceeding \$400.00 for labor and materials, in doing certain painting needed.

The President then presented faculty list for the year beginning with the September semester, to which he had added the name of Miss Lucille Caudill, work to be assigned to her by the President later, at a salary of \$1,600.00 per year and upon condition that she shall pursue her studies in a school approved by the President this summer and each succeeding summer until she shall have obtained a Master's degree, and Judge Young moved that the recommendations of the President be concurred in and approved by the board, which motion was seconded by Secretary Senff and Judge Caudill moved that consideration of the recommendation of Dr. A. Y. Lloyd be postponed for the present, which amendment was accepted by Judge Young and upon a roll call all members of the Board voted Aye, except Dr. Hose voted present and said faculty list in its entirety (save and except the recommendation of Dr. Lloyd) was concurred in and approved by the Board:
