

June 29, 1936

At a special meeting of the Board of Regents of the Morehead State Teachers College, held pursuant to call, at seven o'clock P. M., Monday, June 29, 1936, at the Administration Building, Morehead, Kentucky, Mr. C. B. Bennett, Dr. A. O. Taylor, Mr. D. H. Putnam and Mrs. Allie W. Young were present, and the following business was transacted:

Mr. Donald H. Putnam presented commission from the Hon. A. B. Chandler, Governor of Kentucky, of date June 15, 1936, appointing him a member of the Board of Regents to succeed Dr. J. M. Rose, resigned and said Putnam was then sworn as required by law by Miss Anna B. Carter, Notary Public of Rowan County and entered upon the discharge of his duties.

On motion of Dr. Taylor, seconded by Mr. Bennett and all members of the Board present voting Aye, Mrs. Allie W. Young was elected vice chairman of the Board.

The minutes of the meeting of April 23, 1936, were then approved and ordered recorded on the official minute book of the Board, Mr. Putnam not voting.

On motion of Mr. Bennett, seconded by Dr. Taylor and all members of the Board present voting Aye, Earl W. Senff was reelected Secretary of the Board until the further orders of the Board.

The request of the Citizens Bank that interest on the deposit now in said bank be waived, was then considered and on motion of Dr. Taylor, seconded by Mr. Bennett said request was granted effective July 1, 1935, upon condition that monthly withdrawals be increased from \$500.00 to \$1000.00 and that the purchase price of any property sold and covered by mortgage heretofore given the college be applied to said deposit as per terms of said mortgage.

Secretary Senff then presented interest coupons Nos. 1 to 100 both inclusive of \$20 each from bonds issued in re Docket No. Ky-1060-R (Science Building) and same were delivered to President Babb who was directed to deliver them to the business office where they are to be safely kept for future inspection by proper authorities, said coupons being interest due before delivery and sale of said bonds.

On motion of Dr. Taylor, seconded by Mr. Putnam and all members of the Board present voting Aye, contracts Nos. 3 and 10 on project No. 8879 (Power Plant) were accepted upon recommendation of Messrs. Joseph & Joseph, Architects.

On motion of Mr. Bennett, seconded by Dr. Taylor and all members of the Board present voting aye, the Business Agent of the

college was authorized and directed to release, upon the record book where the mortgage from the Citizens Bank to the college appears of record, the lien retained in said mortgage insofar as same shall apply to any piece of property covered by said mortgage and sold by said bank, when the proceeds of said sale shall have been paid to the college as per terms of said mortgage.

On motion of Mr. Putnam, seconded by Mr. Bennett and all members of the Board present voting Aye, President Babb was authorized to select names and/or inscriptions for the new Science Building and Dormitory now under construction.

On motion of Mr. Bennett, seconded by Dr. Taylor and all members of the Board present voting Aye, the following resolution was adopted:

It appearing that Prof. E. V. Hollis has recently written President Babb as to his status with the Morehead State Teachers College and it further appearing that he had been notified by the then President of the institution, as shown by the correspondence between them, when sabbatical leave was granted him last year, that the college would not avail itself of his services at the end of such sabbatical leave, the Secretary is now ordered and directed to notify said Hollis that the Board of Regents concurs in the position heretofore taken, i. e., that with the granting of the sabbatical leave aforesaid, his services with the Morehead State Teachers College terminated.

President Babb then recommended that leave of absence for the summer, on half pay, be granted Dr. Black and sabbatical leave of absence on half salary be granted Mrs. Silver for next year, and on motion of Dr. Taylor, seconded by Mr. Bennett and all members of the Board present voting Aye, such recommendations of the President were approved and concurred in by the Board.

President Babb then discussed at length with the members of the Board present, the financial status and outlook of the institution for the coming year.

President Babb then presented faculty recommendations for the ensuing year, and on motion of Mr. Bennett, seconded by Dr. Taylor, and all members of the Board present voting Aye, on roll call, page one of such recommendations beginning with the name of Professor H. C. Haggan and ending with that of Professor Ernest Hogge was approved and concurred in by the Board.

On motion of Dr. Taylor, seconded by Mrs. Young and all members of the Board present voting Aye, on roll call, page two of such

recommendations beginning with the name of Miss Naomi Claypool and ending with that of Miss Rebecca Thompson was approved and concurred in by the Board, upon condition that Mr. G. D. Downing and Professor Ernest Hogge are re-elected with the understanding that they are to each take a leave of absence the following year to further pursue their studies.

On motion of Dr. Taylor, seconded by Mrs. Young, and all members of the Board present voting Aye, on roll call, the Administrative Staff down to the Cafeteria list was approved and concurred in by the Board.

On motion of Mr. Putnam, seconded by Dr. Taylor and all members of the Board present voting Aye, resignation of Mr. D. J. Gammage as Cafeteria Director was accepted.

Dr. Taylor then moved that the recommendation of President Babb that Mr. W. H. Rice be reelected Superintendent of Buildings and Grounds at a salary of \$3000 per annum, and that all other recommendations in Cafeteria and Department of Buildings and Grounds lists be deferred until some subsequent meeting, which motion was seconded by Mr. Bennett and upon roll call all members of the Board present voting Aye, said motion was declared duly adopted.
