### **Professional Policies**

Pac-2: Promotional Review was presented for a second reading. The committee approved the following changes:

- 1. Page 1 replace lines 32 and 33 which read "...focus on professional and scholarly judgements regarding the quality and quality of the individual's academic work." With the following: "...make judgements that focus on the quality and quantity of the professional and scholarly performance in the areas of teaching, professional achievement, and service.
- 2. Page 3 modify line 103, which reads: "Professional Service: Service to the institution and the community is recognized, evaluated and expected of faculty....." to be changed as follows: "Professional Service: Service is recognized, evaluated, and expected of faculty....."

The following amendments were made:

- 1. Senator Buck made the following as a friendly amendment: page 3 lines 103 & 104 to read: "Professional Service: Service to the institution is recognized, and evaluated for faculty desiring promotion to professor." Motion was accepted.
- 2. Senator Buck made the following as a friendly amendment: page 7 line 267 & 268 change from: "...include one representative from each college and five additional at large faculty members,...." And replace with "...two representatives from each college and one at large faculty member...." Motion was not accepted.
- 3. Senator Buck made the following motion: page 7 line 267 & 268 change from: "...include one representative from each college and five additional at large faculty members,...." And replace with "...two representatives from each college and one at large faculty member...." Motion was seconded. Motion failed
- 4 Senator Grise' made the following as a friendly amendment: page 9 lines 328 330 to read: "Promotion Portfolio. This additional documentation and supporting evidence will not become part of the portfolio to be sent further up the chain of review. Motion accepted.
- 5 Senator Ried made the following as a friendly amendment: page 9 line 330 add new sentence to read: "However, the original portfolio can not be amended." Withdrew his motion.
- 6 Senator Buck made the following as a friendly amendment: page 10 line 379 replace two-thirds with eight of nine members. Motion was not accepted.
