Motion was seconded. The Senate members discussed the resolution. After discussion, Senator LaFleur moved to table the resolution. Senator Ahmadi seconded the motion. Motion failed. Senator Rathbun moved to commit the resolution to the Senate Evaluation Committee. Senator Stanley seconded the motion. Motion passed.
