The Executive Board of the C W F met on November 2, 1953 at 7:30 PM in the home of Mrs. D. E. Bayless.

The meeting was opened with sentence prayers.

The minutes of the last meeting were read and approved.

The treasurer, Mrs. N. E. Kennard, reported a bank balance of \$129.67, and cash of \$11.50, or a total at that time of \$141.17. Miss Humphrey was asked to compose a letter regarding Women's Day. This letter would be printed and mailed to the women of the church by the secretary of the church.

A motion was made by Inez F. Humphrey and seconded by Mrs. Lena Wilson that the C W F give the choir a dinner on November 18th, '53 at 6 P M, in the basement of the church, and that the executive board be responsible for arrangements. The vote was unanimous.

It was moved by Lena Wilson and seconded by Miss Humphrey, that beginning in January, there would be a fellowship dinner in the church on each 4th Sunday, and that the three circles would take their turns in being responsible for arrangements for these dinners. Circle #1 will be responsible for the January dinner. The vote on this was also unanimous.

Circle #3 was asked to be hostess at the church entrance for the month of November, but when Mrs. Reynolds explained that the young mothers were busy in other parts of the church at that time, or with their own children, two women of Circle #1 volunteered to serve for them.

Mrs. Bayless read a letter from the Kentucky Christian Church Homes, asking that a key woman of the church be named to secure annual pledges of \$1 from members. This project was postponed until January, and Mrs. Bayless named Mrs. Mary Myers as the solicitor.

The Executive Board of the C W F met on November 30, 1953 in the home of Mrs. N. E. Kennard, with the following members present:

Mrs. Kennard, treasurer, gave a report of a balance in the treasury of \$303.56 in the treasury (This was corrected by phone the next day to be \$302.21, and that the sum of \$230 had been sent that day to U. C. M.S.) The treasurer reported that the Woman's Day collection had amounted to \$119.67, and that this amount was included in the balance given.

The service committee's report, given by Mrs. Jane, was that there had been another delivery of clothing to the poor in West Morehead, and that layettes were being asked for in each Circle, and that these would be sent to a missionary for distribution.

It was recommended that each circle vote to take money from the treasury to buy a dining table for the basement of the church.

January 11th, 1954 was set for the next quarterly meeting, and it was suggested that Mr. Dungan be asked to talk on his visit to the United Nations Seminar in New York City.

Meeting was adjourned.
