### **The Problem**

675 Floyd County arrests for drugs and narcotics in 2018.

**1647** Floyd County veterans.

## **Goals of Floyd County Veterans Treatment Court (FCVTC)**

- To implement the FCVTC program and hire a case manager to increase program capacity to serve 9 high risk/needs felony participants annually (36 over 4 years).
- To provide treatment and wraparound services and to develop effective, comprehensive system of care to help an individuals increase abstinence and decrease recidivism.
- To ensure the project implementation and evaluation adhere to objectives and facilitate continuous quality improvement.

Floyd County Veterans Treatment Court Proposal Catchment Area




# The Ten Key Components of **Veterans Treatment Courts**

- Veterans Treatment Courts integrate alcohol, drug treatment, and mental health services with justice system case processing.
- Using a non-adversarial approach, prosecution and defense counsel promote public safety while protecting participants' due process rights.
- Eligible participants are identified early and promptly 3. placed in the Veterans Treatment Court program.
- Veterans continuum of alcohol, drug, mental health and other related treatment and rehabilitation services.
- Abstinence is monitored by frequent alcohol and other drug testing.
- 6. A coordinated strategy governs Veterans Treatment Courts' responses to participants' compliance.
- 7. Ongoing judicial interaction with each Veteran is essential.
- Monitoring and evaluation measure the achievement of 8. program goals and gauge effectiveness.
- interdisciplinary 9. Continuing Treatment effective Veterans implementation, and operations.
- 10. Forging partnerships among Veterans Treatment Court, Administration, Veterans community-based organizations generates local support and enhances Veteran Treatment Court effectiveness.

Fourteen peer reviewed articles were selected based on their relevance to Veterans Treatment Court.
