The Hog Crop of the West, as made up by the Cincinnati Gazette, for the season 1853-54, was rounded off at 2,000 head, and the average weight 211 lbs. Head, at and averaging 21 lbs, will produce for the season 42,000 bushels of pork, or 10,500 barrels. The crop for the year 1852-53, was 2,100,000 head, and will average 210 lbs. head, and will produce 44,100,000 bushels of pork, or 11,025,000 barrels. The average weight of the hogs, at all qualities, 412 lbs, we have an aggregate product of 60,000,000 lbs, and a deficiency of 18,000,000 lbs, or equal to 180,000 pigs, at 200 lbs each.
