

## Register now to be a part of MSU's spring semester

If your New Year's resolution is to move forward toward a better life for yourself, Morehead State University can help you take that all-important first step.

The University is offering a variety of courses that are designed to meet the region's educational needs, and it's not too late to enroll in the spring semester classes you want to take at any of MSU's campuses.

Students at MSU may obtain an education by a variety of delivery modes--the traditional classroom setting, via the Internet, by Compressed Video (ITV), and through Kentucky Educational Television (KET) or correspondence study courses.

Registration for the spring term will be held Thursday and Friday, Jan. 11 and 12, from 8 a.m. until 5:30 p.m. each day in the University's academic departments and at each of MSU's campuses.

Students who have advanced registered for classes may view their Spring 2007 billing online. Payment or deferment of fees can be made by accessing [Eagle Express Lane](#) on MSU's Web site, in person at the cashiers' window located in 207 Howell-McDowell Administration Building, or at any regional campus center.

Deferment of fees cannot be completed by phone. Payment or deferment of fees is due by the close of business on Jan. 13. A \$75 late fee will be in effect beginning the first day of classes which is Tuesday, Jan. 17. Online deferment will end on Thursday, Feb. 2.

From MSU's Web site, current students may view the 2007 Class Directory and Business Guide to register for classes, pay fees and holds, order textbooks and view transcripts, grades, official academic checksheets, transfer course equivalencies and academic policies via [Eagle Express](#). Textbooks for the classes are available from the University Bookstore, located in the Adron Doran University Center. ## MSU police officer recognized

Morehead State University police officer Mark Stidam was among the law enforcement officers, agencies and individuals from across the state that were recognized for outstanding achievement at the 2006 Governor's Impaired Driving Enforcement Awards ceremony held at the Galt House in Louisville.

Morehead State University's Police Department arrested 32 impaired drivers from Oct. 1, 2005, through Sept. 30, 2006. Stidam topped the MSUPD with 16 arrests.

The Kentucky State Police Honor Guard performed the Presentation of Colors, followed by the singing of the National Anthem by Trooper William Gregory. Kentucky Vehicle Enforcement Commissioner Greg Howard provided the Invocation for the ceremony.

Kentucky State Police Commissioner Jack Adams was joined by Justice and Public Safety Cabinet Secretary General Norman E. Arflack in presenting

awards to 192 officers from 187 law enforcement agencies for their extraordinary efforts in reducing impaired driving.

"In Kentucky alone, there were 5,458 alcohol-related collisions in 2005," said Adams. "As a result of those collisions, 220 people were killed.

"Last year, you contributed to the 28,785 total arrests in this state. Let us not forget that each arrest for impaired driving may in fact be a life saving effort," he added.

Justice Secretary Arfleck also addressed the award recipients. "This award ceremony recognizes your work and dedication to saving lives of Kentuckians," he said. "These officers are proof positive that the problem of driving under the influence can, and will be overcome."

Mothers Against Drunk Driving Kentucky (MADD) recognized two organizations for their dedication and commitment to the DUI Standards Project. The DUI Standards program partners law enforcement with prosecution and the judiciary to identify strengths and weaknesses in DUI enforcement, prosecution, and adjudication to overcome barriers within the DUI system.

Stidam has been with the Morehead State University Police Department since 2002.

## Dr. Prater receives teaching award

Dr. Phil Prater, associate professor of veterinary technology at Morehead State University, has been awarded the American Association of State College of Agriculture and Renewable Resources' (AASCARR) Outstanding Teaching Award.

The award is presented to faculty teaching in the area of agriculture with more than five years of teaching experience. Dr Robert Kinucan, president of AASCARR, made the presentation at AASCARR's annual meeting held at California State Polytechnic University in Pomona, Calif., on Oct. 23.

Dr. Prater received one of the two outstanding teaching awards the organization presents annually. AASCARR is a national organization composed of approximately 50 state colleges and public non-land grant universities which emphasize degree programs in agriculture and related disciplines. Annually AASCARR institutions award approximately 40 percent of the undergraduate degrees in agriculture and renewable resources.

A \$500 award is given to recognize and honor outstanding teachers of agriculture. Dr. Prater was nominated for the award by Dr. Lane Cowsert, former chair of MSU's Department of Agricultural and Human Sciences, with support from Dr. Gerald DeMoss, dean of the College of Science and Technology.

"Dr. Prater is not only an outstanding teacher, but he also provides outstanding service to the university, the community and his profession," said Dr. Cowsert in his recommendation.

In 2006, Dr. Prater also was presented the Kentucky Veterinary Medical Association's (KVMA) Veterinarian of the Year Award for outstanding service to the veterinary profession.

Dr. Prater received his Doctor of Veterinary Medicine degree from the Ohio State University and completed a residency in Theriogenology at the University of Tennessee at Knoxville. He came to MSU in 1998 from the Bedford Hill Veterinary Hospital which he owned and operated in Paris. His years of practice have contributed to his being nominated as an outstanding teacher in the classroom.

## Crisis strategies reviewed at MSU

Emergency service leaders from the community met with Morehead State University administrators and staff members on Jan. 4 to exchange ideas and crisis response strategies.

MSU's Jeff Barker, environmental health and safety technician, and Harry Gunn, risk and compliance manager, presented three mock scenarios for the group to consider. Participants were encouraged to offer suggestions on appropriate actions that should be taken for each proposed situation, which included

a residence hall fire (both with and without casualties) and a scene where an athletic team and others are stranded on campus due to severe weather.

The group examined such issues as incident command and management, potential relocation of students, media information distribution, law enforcement investigation, safety procedures and communication concerns.

Most importantly, according to Barker, it was emphasized that each member know the importance of their role in the event of an actual emergency.

Morehead's new fire chief, Brad Wade, and John Northcutt, assistant fire chief and Rowan County coroner, attended the session and provided insight into their respective responsibilities and duties in responding to a campus situation.

Joseph S. Cline, MSU's chief of police, said that Morehead State enjoys a good working relationship and a spirit of cooperation among community organizations such as the fire and police departments, which smoothes emergency response efforts of all involved. He explained while it may be unlikely that an emergency of drastic proportions will ever strike Morehead State, considering that very possibility is a good idea.

"We need to prepare for the worst, but we can always scale back for the situation if we need to," he said.

## Department of AHS has new chair

Dr. J. Mike Phillips, the former director of the University of Arkansas Southwest Research and Extension Center, has been named chair of Morehead State University's Department of Agricultural and Human Sciences, effective Jan. 2.

His appointment was announced by Dr. Gerald DeMoss, dean of MSU's College of Science and Technology. "We are very fortunate to have someone with Dr. Phillips experience to accept a position on the Morehead State campus," Dr. DeMoss said. "His expertise in all aspects of agriculture and livestock will be most beneficial, as well as his success as a grant writer."

Dr. Phillips succeeds Dr. Lane Cowser, who retired Dec. 31, as department chair.

As Southwest Research and Extension Center director, Dr. Phillips' primary responsibilities included the coordination of a multidisciplinary team of scientists and extension specialists to develop research and extension programs targeted to solve agricultural problems limiting the agriculture of southwest Arkansas producers.

Prior to his director post, he rose through the ranks from assistant to associate to a full professor at the University of Arkansas. In addition to his teaching duties, he served as an adviser or co-adviser for two doctorate and 12 master's programs.

Dr. Phillips has written or co-written and received more than 25 grants, four of which were valued at more than \$200,000. He has had more than 100 journal, refereed/peer-reviewed articles and agricultural experiment station papers and reports published. His works have included a variety of topics such as grasses for pasture, raising beef cattle, fertilization of the soil, and the livestock diet.

He earned his Ph.D. and master's degrees from the University of Arkansas and his bachelor's degree from the University of Arkansas at Monticello.

Dr. Phillips has been the recipient of numerous awards and honors including the Distinguished Service Award from the Southern Pasture and Forage Crop Improvement Conference; Merit and Presidential Citation awards from the American Forage and Grassland Council (AFGC); and Career-Professional Award in Technology Transfer from the American Society of Agronomy (ASA-CSSA-SSSA).

A 2004 graduate of the ESCOP/ACOP Professional Leadership Program, he holds membership in various professional organizations where he also held leadership positions: American Forage and Grassland Council (Board of Directors 2001-03), American Society of Agronomy (chair-elect of A7), Research Center Administrators Society (2006 president), and chair of the Southern Pasture and Forage Crop Improvement Conference in 2001-02. He is currently president of the University of Arkansas at Monticello Agriculture Alumni Society.

He and his wife, Tandra, are the parents of two young children, Amanda Renee and Christopher Michael.

## Meadows serves on editorial review board

Retirement doesn't have to mean that professional improvement and scholarly work ends when you leave your job, according to Dr. Robert (Bob) Meadows of Morehead.

Dr. Meadows, a Morehead State University professor emeritus of management, believes that one can contribute to an academic field and be as productive as an individual's health, interest and circumstances will allow.

To that end, he continues to review business cases, serving on the editorial review board of "Business Case Journal (BCJ)," published by The Society for Case Research (SCR). The organization, formed in 1978, assists professionals who conduct case research, teaching and writing in the broader field of business education. Dr. Meadows is a past recipient of SCR's Distinguished Service Award, and was the BCJ's 2004 Reviewer of the Year.

One of his papers, "Some Observations on Reviewing Cases," was printed in the journal's latest issue, which reportedly has about a 10 to 20 percent acceptance rate for submissions.

"This journal is for teachers who want to use business cases in the classroom," he said.

Dr. Meadows came to MSU in July 1982, as the head of what is now the Department of Management, Marketing and Real Estate. The Ohio native also taught undergraduate courses in production management and graduate courses in organizational theory and quantitative theory. He retired as department chair in 1996. Prior to his tenure at MSU, he was a department chair at Westminster College in Pennsylvania.

"I think that you can stay involved in your work after retirement," he said. "You don't have to just sit home and do nothing, and you can still be active in your profession."

While at MSU, Dr. Meadows was honored with the University's 1995 Distinguished Service Award for faculty. Additionally, he served as the director of the Small Business Institute for more than a decade. The Institute used students to help smaller East Kentucky companies solve a variety of problems, from setting up computer systems to developing advertising campaigns and testing inventions.

As a management professor, Dr. Meadows and a group of graduate students assisted the Sealmaster plant in Morehead achieve ISO-9001 certification, making the plant at that time the world's only bearing plant to achieve that status.

Dr. Meadows earned his baccalaureate degree from Ohio University, and the Master of Business Administration and Doctor of Business Administration degrees from Kent State University.

## Secure network will allow exchange of health information

Morehead State University and St. Claire Regional Medical Center have announced the formation of the Northeast Kentucky Regional Health Information Organization (NEKY-RHIO).

Still in its formative stages, NEKY-RHIO will support adoption of electronic medical records by healthcare providers and offer a secure, regional network for exchange of health information. The goal is to improve the quality and efficiency of health care and empower consumers to more effectively manage their healthcare needs.

The formation of the NEKY-RHIO evolved through the collaboration of Dr. Elizabeth Regan, chair of MSU's Department of Information Systems and J. Randall McCleese, vice president and chief information officer at St. Claire Regional.

"Applying the combined resources and expertise of SCR and MSU to pursue the development of a regional health information network has tremendous potential," said SCR President/CEO Mark J. Neff. "The electronic health record and the ability to securely and efficiently exchange that information is our primary goal."

"We are very pleased to be teaming with St. Claire Regional on this project," said MSU President Wayne D. Andrews. "President Bush made e-health a major priority. We believe that NEKY-RHIO is a unique venture in technology and the medical field."

The NEKY-RHIO collaboration also will promote economic development opportunities within the region through increased investment and job creation in health information technology as well as a healthier and more productive workforce.

With the growing focus on e-health technology at both the state and national levels, Regan and McCleese recognized the opportunities for improving regional healthcare as well as promoting economic development opportunities for the surrounding area. As they explored the idea with many of region's leaders and healthcare professionals, it became evident that the concept had very broad support and was addressing a growing need.

With health information exchange, patients can allow physicians at one institution to see what treatments they received from another, an ability that can improve follow-up care and reduce duplication procedures. When patients are referred to another institution, they can be assured that their record of care is transferred along with them. Lab tests, x-rays, and other procedures can be ordered electronically and the results returned promptly to the doctor. Chances of errors and delays are greatly reduced.

Care givers, who have responsibility for a loved one in a neighboring community or across the country, would have access to medical information. It also means that when prescribing medications, physicians would have an accurate record of a patient's medications, and that the system would check and alert the physician if there was a risk of adverse reactions.

Patients would have another advantage as medications could be refilled electronically. When out of the state or out of the country and a medical need arises, a patient's medical records would be readily accessible.

A NEKY-RHIO Steering Committee was established with representation from MSU and , as well as Northern Kentucky University, Morgan County Regional Technology Center, the East Kentucky Innovation Center and several clinical practitioners.

The Steering Committee has held several meetings to educate the membership along with field trips to CareSpark Health Information Exchange in Kingsport, Tenn., and the Veterans Administration e-Health Network.

Rounding out the committee are: Thomas J. Ruthemeyer, special assistant to the associate provost for economic initiatives at Northern Kentucky University; and Porter Dailey, director of the Morgan County Regional Technology Center.

The NEKY-RHIO is one of only three regional health information organizations in Kentucky and has representation on both the Kentucky E-Health Network Board and the Kentucky E-Health Network Advisory Group. The NEKY-RHIO also has attained membership in the Health Information Systems Management Society National RHIO Federation.

## MSU Chief Cline to serve on new campus safety task force

FRANKFORT- Morehead State University Police Chief Joseph S. Cline is among 15 persons appointed Tuesday by Gov. Ernie Fletcher to the Governor's Task Force on College Campus Safety.

The task force is charged with conducting a comprehensive examination and evaluation of campus safety by reviewing the adequacy of safety and security standards at the public and private postsecondary institutions throughout Kentucky. The group's mission includes the development of new legislation for consideration by the General Assembly.

MSU's police chief since 2003, Cline joined the force in 2001 after serving as a patrolman and detective in the Morehead Police Department. He is a Kentucky Law Enforcement Council certified police instructor and a graduate of the FBI National Academy. He also holds a bachelor's in criminal justice. Cline and UofL Police Chief Wayne Hall are representing the state's law enforcement community.

The task force will be chaired by Gail Minger, whose son, Michael Minger, died in a dormitory fire at Murray State University in 1998. She lobbied for



legislation, ultimately passed in her son's name, that requires Kentucky colleges and universities to document and report campus crimes to campus employees, students and the public.

"The passage of the Michael Minger Act in 2000 began a process of making campuses safer for students, faculty and staff. This task force will continue that important work," said Gov. Fletcher. "I want to thank Gail for her diligent work in the area of campus safety and for her willingness to chair this group that will address safety issues that are important to students and parents across this Commonwealth."

The group will focus on the institutions' compliance with Kentucky laws, regulations and building and fire codes that pertain to residential facilities and classroom buildings. Its purview also will include safety policies and procedures on fire safety, crimes and law enforcement investigations into serious campus crime.

The mission of the task force includes developing recommendations for legislation; developing policies and initiatives for heightened security and safety for the protection of campus residents, facilities, and the environment; and establishing broad systematic initiatives that will enhance safety and security across the commonwealth's campuses.

The task force plans to conduct open forums at which students and staff can express concerns about security and suggest solutions to perceived problems.

"Our sole mission is to improve safety standards and bring about a safer living and learning environment for all college students and their campus communities in Kentucky," Ms. Minger said.

## 'We are Marshall' showing at University Cinema

The film tells an inspiring true story set in Huntington, W.Va., a small town steeped in the rich tradition of college football. For decades, players, coaches, fans and families have come together to cheer on Marshall University's "Thundering Herd."

For this team and this community, Marshall football is more than just a sport, it's a way of life. But on a fateful night in 1970, while traveling back to Huntington after a game in North Carolina, 75 members of Marshall's football team and coaching staff were killed in a plane crash.

As those left behind struggled to cope with the devastating loss of their loved ones, the grieving families found hope and strength in the leadership of Jack Lengyel, a young coach who was determined to rebuild Marshall's football program and in the process helped to heal a community.

To help filmmakers accurately portray events, Morehead State athletics and the Camden-Carroll Library's Special Collections and Archives supplied MSU material for the movie and received props from the film, including a jersey, a call list for filming and storyboards that chart the plays required for the game scenes.

It was 35 years ago (Sept. 18) that both communities joined together for an extraordinary event. Marshall visited Morehead State to play its first football game since the tragic plane crash.

The game was more important than the 29-6 Morehead State victory. As the Young Thundering Herd ran onto the field at Jayne Stadium that Saturday night, they did not receive the usual chorus of boos for the visiting team, but both sides rose for a standing ovation.

## Grant awarded for e-Health initiative

A cooperative effort between St. Claire Regional Medical Center and Morehead State University has yielded a \$81,000 grant from the state to help health providers in the region implement electronic medical records and e-prescribing.

The announcement was made by Gov. Ernie Fletcher at the state's first e-Health Summit, held Jan. 19, in Louisville. On hand for the announcement were members of the Kentucky e-Health Network Board, the Cabinet for Health and Family Services and Dr. Robert Kolodner, U.S. health and human services coordinator for health information technology.

During his keynote address, Gov. Fletcher touted the possibilities of e-Health, the term used to describe an electronic health care network. Joined by leaders in technology, health care and other business fields, the governor gave a broad overview of e-Health achievements in Kentucky and mapped future plans and goals to advance the field.

"Today we stand on the cusp of a new wave of innovation and change that will fundamentally reshape the health sector of our economy, as well as how we think about health and wellness," said Gov. Fletcher. "In the same way that technology and Web-based communication have transformed every other sector of our economy, instant access to information when we need it is going to do the same thing for health and health care. This means that we are making the health care system more efficient and user-friendly for both patients and providers."

The grant funds will help St. Claire Regional implement e-Prescribing and electronic medical records in the hospital's five primary care clinics. According to Dr. William Melahn, project manager and president of the medical staff association, "the clinics will be linked by a secure network with local pharmacies to electronically submit or renew prescriptions. Doctors also will be able to access patient information from the hospital if necessary, as well as their offices."

Another leader behind this initiative, family physician Dr. Mary Jane Humkey, said "the system will also help doctors check for possible drug interactions. E-Prescribing has been shown to save time, reduce errors, and offers patients a new level of convenience and safety."

In addition to St. Claire Regional Medical Center, monetary awards for health care providers wishing to implement e-Health were presented to Baker Family Care in Neon, \$10,000; Kentucky Primary Care Association Inc. in Frankfort, \$81,000; and University of Kentucky North Fork Valley Community Health Center in Hazard, \$81,000.

The summit provided an opportunity to discuss the progress, opportunities and challenges facing Kentucky as the state works to develop and implement e-Health, a computerized medical information

network to improve patient privacy, reduce medical errors, lower administrative costs and help make electronic medical records available to more Kentuckians.

The vision of Kentucky's landmark e-Health legislation passed in 2005 was to lower costs, increase quality and improve health outcomes. The e-Health Summit brought state and community leaders involved in e-Health initiatives throughout Kentucky together to learn more about the efforts of the Kentucky e-Health Network Board and various local health information exchange efforts.

Announcement of the initiative was on the agenda when the Northeast Kentucky Regional Health Information Organization met on Monday at St. Claire Regional. On hand were Mark Neff, SCR president; CEO; J. ## New program to benefit lowest income students

In the spirit of its 120-year tradition as an institution of opportunity for residents of East Kentucky, Morehead State University has announced that, with a program starting this fall, its lowest income students will not be turned away when their personal resources and financial aid fall short of meeting their college expenses.

The program is called "Eagle Access" and it will be available to help finish paying for tuition, meals, housing and books for students whose family incomes qualify under federal guidelines.

"Our goal is to fill the gap for these students who are concerned they simply won't have enough money to pay for college," said MSU President Wayne D. Andrews. "Students from low income families are at the

greatest risk of leaving college or staying away because of financial worries. We want them to know that, if they follow certain steps, Morehead State University will be there to help in a new and important way."

Dr. Andrews said "Eagle Access" was initiated as part of MSU's ongoing efforts to increase the number of students who can successfully complete four-year degrees.

"We cannot continue to move this area of our state forward unless every qualified student has an opportunity to follow their dream of a college education," he added. "This new program will allow us to assist those families most affected by the increasing cost of going to college."

Specifically, the program is intended to benefit Kentucky residents who enroll at MSU on a full-time basis as an entering freshman this fall. Potential applicants are advised to go to [www.moreheadstate.edu/prospective](http://www.moreheadstate.edu/prospective) and click the Eagle Access button for other details. If accepted, they can receive this special assistance for as many as 10 semesters of undergraduate study. ## Kulick is honored as female Bowler of the Year

Former Morehead State University bowler Kelly Kulick of Union, N.J., has been voted female Bowler of the Year for 2006 by the members of the Bowling Writers Association of America.

The announcement was made earlier this month by BWAA President Hazel McLeary.

Kulick's greatest achievement was qualifying for the Denny's PBA Tour for the 2006-07 season.

She also captured the Rome, N.Y. regional, to become only the second woman to win a PBA regional title, and she finished 33rd in the USBC Masters among a field of more than 600.

Kulick garnered 72 first place votes, 41 seconds and 18 thirds for 460 points. Liz Johnson, of Cheektowaga, N.Y., a former teammate of Kulick's at Morehead State, was runner-up with 358 points.

Johnson made history by becoming the first woman to win a PBA regional and finished second in a PBA national event in 2005.

Kulick made it to the Professional Women's Bowling Association Tour, earned the 2001 Rookie of the Year, and even won the 2003 U.S. Open, a major tournament on the professional level.

Kulick, a three-time All-American, was the 1997 and 1998 Collegiate Bowler of the Year while at MSU. In 1998, she helped guide veteran coach Larry Wilson's squad to the National Championship.

The MSU women won national championships in 1989, 1998, 2000 and 2002, were runner-ups in 1993 and finished in third place in 2006. The men's squad was runner-up in its 2003 tournament and took third place in 2005.

## Holbrook receives Al Smith Fellowship

Chris Holbrook, assistant professor of English at Morehead State University, has received his third prestigious Individual Artist Al Smith Fellowship for fiction writing from the Kentucky Arts Council.



This was one of 13 fellowships awarded to outstanding Kentucky writers, choreographers and musical composers in 2007.

The \$7,500 awards named for Al Smith, journalist and former Arts Council chair (1977-1980), alternate between two discipline groupings: writers, composers, choreographers, and interdisciplinary artists in one year and visual and media artists in the other.

Holbrook's short stories have appeared in a variety of literary journals including "The American Voice, Appalachia Heritage, Wind, Night Train," and "Appalachian Journal." His work also has been included in the anthologies "Home and Beyond: A Half Century of Short Stories by Kentucky Writers" (University Press of Kentucky, 2001); "A Kentucky Christmas" (University Press of Kentucky, 2003); "Missing Mountains" (Wind Publications, 2005); and "The Kentucky Anthology" (University Press of Kentucky, 2006). His book of short stories, "Hell and Ohio: Stories of Southern Appalachian," was published by Gnomon press in 1995.

Before joining MSU's Department of English, Foreign Languages and Philosophy in 2003, Holbrook taught English at Alice Lloyd College. He earned an M.F.A. degree in fiction writing University of Iowa and has completed residency fellowships at the Fine Arts Work Center in Provincetown, Mass., and at Yaddo in Saratoga Springs, N.Y.

Holbrook, a Lexington resident, was the 1997 recipient of MSU's Thomas and Lillie D. Chaffin Celebration of Appalachian Writings Award. He received Al Smith awards in 1988 and 1998.

## Hunt Memorial Scholarship has been established

Morehead State University has announced that a Dr. Richard Hunt Memorial Scholarship has been established for students who wish to pursue a degree in chemistry.

The Hunt scholarship is named for Dr. Hunt, a former associate professor of chemistry at MSU. A 1973-74 Fulbright Fellow, he was a graduate of Antioch College where he earned a B.S. degree and the University of Chicago where he completed the Ph.D. degree.

The scholarship, administered through the MSU Foundation Inc., was established on behalf of faculty, alumni and friends of the MSU Chemistry Program, and coordinated by Dr. Mark Blankenbuehler, associate professor of chemistry.
