The afternoon session was conducted by Vice President Hartley Battson. The subject of "Finding and Training Leaders" was discussed by Rev. Sweazy and Mr. Vaughan.

County Superintendent's Statement

Owing to the congestion of the teachers in Rowan County and in the State, Rowan County will cooperate and raise the standard of the qualifications of teachers in this county to meet the standard suggested by the State which is above the required standard.

Due to the increase in the value of the Rowan County Board of Education agreed at a meeting held on March 21, 1931, to discontinue the services of the trustee officer in the county and these duties are to be performed by the County Superintendent and the Sheriff of this county.

They also voted to decrease all expenses of maintaining and operating the 4 schools in proportion to the decrease in property values. And in addition the Board adopted and approved of the budget for the school year of 1931-32, the sum of \$5,000 having been set apart and provided in said budget for the purpose of creating a sinking fund to pay the interest and principle of a contemplated bond issue, the pay-

ment of which is conditioned that the claimants must have their claims reduced to judgment by a court of legal jurisdiction for the purpose of testing the legality of such claims and authorizing the Board to perform this duty.

The Teachers of the county have all been paid for their services for the year 1930-31. We are now working on the annual audit which will be published in detail after the end of the present school year, June 30th, 1931. It appears from said audit that after having paid all the claims authorized by the County Board of Education, there will be approximately the sum of \$1,200 in the treasury to the credit of the County Board of Education.

We the members of the county understand the affairs of their schools which all parents and citizens are equally interested, and we are always ready to do anything we can for the advancement of the schools.

Every professional man goes away and stores up knowledge so he may do his work in the best possible way. It is absolutely necessary for people to go away so they may get a renewed viewpoint. In other words it is to get a new star age battery for the old one that is worn down until it hardly makes an impression. It always takes more power to produce light than it does to produce noise.

When we are stored up with power what is it for? There must be driving power, said the speaker. Unless we have the driving power we will store up the energy without being able to use it. The driving power is essential to put across the program. That is the reason a body of people like a club can go out and put things over in a fine way, because they have stored energy and a good amount of driving power.

Stored power and driving power struck at the same time in that statement. It was the strength of that matchless power to draw people. SUDAN GRASS IS DROUGHT RESISTANT
As increasing number of Ken

tucky farmers are sowing Sudan grass which now is considered more drought resistant than any other crop, that can be sown in June and July for hay and pasture. The college of agriculture University of Kentucky says the seed bed should be prepared the same as for corn and 20 pounds sowed either with wheat drill or broadcast and harrowed. Sudan grass will pasture one thousand to two thousand pounds of live stock to the acre from the time it is a foot high until killing frost. As a hay crop it will cut two to five tons to the acre depending on the fertility and rainfall.

According to Dr. G. C. Nickell, County Health Officer, too much care cannot be taken of such things because it is one of the most dangerous diseases if not properly looked after. There is a popular belief he said, that the danger of contracting the disease passes after a period of from nine to twenty one days. This is not true. Cases have been known, he stated in which the disease developed six months after being exposed. He advises every person who has been so exposed to immediately begin taking the serum injections as a guarantee of safety and immunity.
