

: : **EXECUTIVE COMMITTEE REPORTS**

President: Chando went to Richmond for the tuition hearings last week. He said that the Council on Higher Education will probably raise the tuition by 20% for next year. The student body presidents are upset that tuition will be raised because of the budget cuts. Chando commended Lance George for his work with the Food Services committee and told everyone that Taco Bell prices are higher because of a service charge but the food is still more inexpensive compared to other foods offered by the university. MSU Basketball broke its losing streak, defeating Austin Peay on Monday night. The Student Regents and Presidents will be meeting with the Governor.

<u>Vice-President</u>: Denise said that she had some things to say during committee sessions.

Secretary: I read a letter from Alpha Phi Alpha and Alpha Kappa Alpha regarding their second annual Skee-Phi Week coming during the week of February 15th thru 21st.

<u>Treasurer</u>: Bryan said that we have 48,988.20 in the Special Events Fund and 6,544.49 in the Administrative Fund.

<u>Programs Director</u>: Bryan said that MSU won its first ballgame on Monday and they will be playing away this weekend. MSU will play Eastern next Thursday at the AAC, January 28th.

Public Relations Director: Dennis has Velcro Wall posters for the hall presidents to pick up.

COMMITTEES Residence Life---will meet next Tuesday at 6:00 in Fields Hall. Denise discussed her meeting with the committee chairs. She said that if the committee is not doing the work then the committee chair will be replaced. If a committee chair cannot be at the meeting, then he or she should find someone to represent the committee. Denise needs the meeting times from each chair.

The Student Government Association members feel that in order to better serve the students of Morehead State University, that our budget should be a percentage basis, utilizing enrollment to drive the total allotment.

We understand that in changing the method of our budget allotment we set ourselves up to receive less funds in the case of a decrease in the student population. We also understand that our allotment would increase in the case of a increase in the student population.

At this time, we have not determined the exact percentage rate that should be used. We feel it should be based on the present ratio of our budget to one-half of total fees received for the student activity fee of the 1992-93 year, and we feel that this figure can be easily determined with your assistance.
