Laws Relating to Newspaper Subscriptions and Taxes.

We give the following law which it stands:

"Any person who does not give express notice to the contrary, are considered as wishing to continue their subscription."

If subscribers under the above conditions do not give express notice, they may continue to send them until all arrears are paid.

If subscribers neglect or refuse to take their periodicals from the office in which it is sent, and do not give express notice, they may have settled their bills and ordered them discontinued.

If subscribers move to other places, without informing the publisher, he will consider them as having moved forever.

If subscribers under the above conditions do not give express notice, they may continue to send them until all arrears are paid.

If subscribers receive a newspaper and make use of it, whether he has ordered it or not, he will be charged for it.

If subscribers pay in advance, they are bound to give notice to the publisher before the time it is due.

If subscribers do not wish to continue taking it; otherwise the publisher is at liberty to accept payment in full, and will be responsible to him.

It is the duty of the publisher to make up payment of all arrears, it is well to the publisher's interest.
