

## Death Claims Widely Known Morehead Man

MOREHEAD, Ky., April 3 (Special)—Judge Elijah Hogge, former special circuit judge of Rowan and a member of the law cial)—Judge Elijah Hogge, former special circuit judge of Rowan county and a member of the law firm of Hogge and Hogge, died at 5:30 o'clock today at his home here as the result of a heart attack. He had been in ill health for two years.

Judge Hogge, father of Walter Hogge of Lexington, was one of Rowan county and Morehead's leading citizens and, with the late Judge Allie Young, was instrumental in

ing citizens and, with the late Judge Allie Young, was instrumental in having the Morehead State Teachers College located here. He was widely known also as a lover of thoroughbred horses and from 1922 to 1934 served as steward of the Kentucky Jockey Club.

He was born at Whitesburg, May 25, 1869, but moved to Rowan county with his parents when he was two

25, 1869, but moved to Rowan county with his parents when he was two years of age. He was educated in the common schools of Rowan county and, after teaching for four years. studied law and was admitted to the bar in 1897.

For many years he was a member of the legal firm of Young, Clay and Hogge, in which he was associated with the late William A. Young, the late Judge Allie Young and James Clay.

He served as Roman county attorney from 1913 to 1917, and mayor of Morehead from 1918 to 1921. Since 1934, he had been a member of the legal firm of Hogge and Hogge, associated with his relative, Lester Hogge.

## Political Leader, Elijah Hogge, Dies From Heart Attack

### Was Chairman Of Democratic Party In Rowan For 24 Years

Elijah Hogge, 69, one of Eastern Kentucky's best known political leaders, died at his home here at 5:30 o'clock Monday morning after a heart attack.

Funeral services were conducted at the Baptist church Wednesday afternoon and were attended by many friends. The Rev. B. H. Kazee, assisted by the Rev. A. E. Landolt and the Rev. G. B Trayner, conducted the services. ner, conducted the services. In-terment was in Lee cemetery after rites conducted by the Masonic lodge.

Death was not unexpected as he had been suffering from attacks for the last three years which had practically forced his retirement from his law practice. He had an attack at 3:30 Monday morning and steadily grew worse

until the end.

Judge Hogge was a steward of the Kentucky Jockey Club from 1922 to 1934, spending around three months of each of these years officiating at Churchill Downs and Latonia racetracks. He was chairman of the Democratic party in Rowan county for 24 years, being elected every four years without opposition. This his health became bad and he relin quished this post which was taken over by his law partner, At-torney Lester Hogge.

Judge Hogge served as attorney of Rowan county from 1913 to 1917 and was Mayor of Morehead from 1918 to 1921. He held numerous other honorary appointing tive positions but with the excep-tion of making the races for county attorney and mayor preferred to place his friends in office. He was a powerful figure in state politics for 20 years, being closely aligned with the late Senator Allie W. Young. They were in almost constant association for many years and it was a short time after Senator Young died that Judge Hogge's health became bad.

He worked in many places after his army service, buying, shipping horses from Ohio and other states to New York, finally coming to Kentucky about 35 years ago. Here he married Lou Howard. He worked here as a vetenarian, having the reputation of being an outstanding animal doctor.

# Last Surviving Veteran Cf Civil War Dies

### Dr. "Uncle Joe" Jamison Passes At Age 95; Impressive Funeral Rite Held

Dr. "Uncle Joe" Jamison, 95, lone surviving veteran in Rowan County of the Civil War, passed away quietly at his room at the Midland Trail Hotel, after an illness of several weeks.

The end came as Uncle Joe's eyesight began to fail him. For several years he knew that the end was near, and although he enjoyed the last year's of his life to the fullest he, nevertheless, was prepared for death. Shortly before he died he said that "I am living on borrowed time."

During the Civil War Dr. Jamison served with the 120th Regiment of the Ohio Volunteer Infantry, composed during the War of 1405 men. Of the 1405 Dr. Jamison is next to the last to die, the remaining one being William Rittenhouse of Ashland, Ohio.

Across the fields of the historic Gettysburg battlefield last summer Dr. Jamison clasped the hand of his lone remaining buddy. That hand clasp and that trip, sponsored by the United States government perhaps meant more to Joe Jamison than anything in his life.

"Uncle Joe" Jamison served four years in the Civil War with the Union forces. The last thirteen months were in a prison camp near Tyler in Smith County, Texas. He was taken, along with 300 other Union soldiers a prisoner at the battle in Snaggy Point, La.

### A Great Citizen Passes

Elijah Hogge has passed to his reward.

He lived a full life and for two decades it was a service to Morehead and Rowan County. He loved his people and his people held in him the type of man that is a great credit to any community; a citizen that helped in a great measure to make Morehead what it is.

He was closely aligned during his lifetime with the late Senator Allie W. Young and one of the saddest blows of his life was the passing of Judge Allie. They worked together to accomplish the great things to help the people of Morehead. Judge Hogge was instrumental in securing the establishment of the Morehead State Teachers College. Hundreds of other times he used his influence to secure better things for his people of Rowan County.

Rowan County has a reputation of being one of the hottest political beds in Kentucky. Yet, Judge Hogge was named chairman of the Democratic party for 24 years, virtually without opposition. He retired when his health became bad. It is a tribute to him that all the members of the party despite factionalism, held for him and his fairness and honesty in politics as in everything else, that they honored him with this position for so long.

He gave generously and freelly of his time and money for a score of years to Rowan County.

It must be a great satisfaction to the surviving members of his family to know that as his remains lie in Lee Cemetery there is, nevertheless at every hand, reminders of his accomplishments for us.

Elijah Hogge was the type of citizen that every community must have if it is to be progressive. Perhaps in the Great Beyond he is even now sitting and chatting with his life-long friend, Senator Young, as they sat and talked and planned for us better things during their lifetime. His life is a glowing example of what is fine and generous in a great man.

I bow my head in silent player to Lige Hogge. In all his illness he still kept his smile. Regardless of where he saw me, it was always, "How are you, Woody?" I am going to miss my devoted friend, my pal. Your memories, your cheerfulness, will linger with us. Good-bye, Lige, we are going to miss you.

# Death Claims Elijah Hogge, At Home Here

### Was Powerful Figure In Politics; Served As Race Stewart For Twelve Years

Funeral services for Elijah Hogge, 69, powerful political figure in Rowan County and Eastern Kentucky for many years, were held at the Baptist Church Wednesday afternoon at 2 o'clock. Interment followed in the Lee Cemetery.

Judge Hogge died at 5:30 Monday morning following a heart attack. The attack came at 3:30 and he grew steadily worse until the end. His death was not unexpected as he had been in ill health for the last four years and was forced to a Lexington hospital on two occassions.

Born at Whitesburg, Ky., May 25, 1869, his family moved to Rowan County when he was two years old. He was educated in the common schools of Rowan County and taught here four years. He studied law under the late William A. Young and was admitted to practice in 1897. He was a member of the firm of Young, Hogge and Clay until 1934 when he and his nephew Lester Hogge formed the partnership of Hogge and Hogge in which Judge Hogge was the senior member until his death.

He was forced into virtual retirement four years ago because of illness. Judge Hogge was chairman of the Democratic party in this county for 24 years, being elected most of the time without opposition. He voluntarily relinquished this place three years ago and it was assumed by his law partner.

Judge Hogge was a fancier of thoroughbred horse racing in Kentucky and served as a Stewart of the Kentucky Jockey Club from 1922 until 1934. During this period he spent around three months each year officiating at the Churchill Downs and Latonia race tracks.

He was closely associated with the late Senator Allie W. Young in (Continued On Page Four)
