Roy read from page 65, of the 1982 Assembly Business Document, August 26-28, 1982 pertaining to this fact. Mary gave a brief history of her church and invited the Board as well as church members to visit her and her church. Roy announced at this time that it was scheduled for Mary to have her installation ceremony on February20,1983. He and various members of the church plan to attend this ceremony. Jack Bizzel called for a round of applause for Mary which was given by the attending Board members. Ival expressed his congratulations and those of the Board for Mary's new position, at the Mill Creek Christian Church.

Two Changes were noted in the minutes of November, 1982:

1. Hubert Allen was in attendance instead of Woody Allen,

2. The Worship Committee report was left off-presented by Jeannie Huie and dealt with the plans for the Christmas season.

Motion was made by Elmer Anderson and seconded by Ron Hart that the minutes be accepted with above corrections. Motion passed.

TREASURER'S REPORT: Alex Conyers presented the treasurer's report at this time. He noted that the month of December ended with a \$1,000 debit. At this time, Roy discussed the outstanding church debit which was \$804.82. This is the debit that is being eliminated by the Special Offering format. With one fifth Sunday left and Easter Sunday, the debit is on the way of being paid off. Roy presented a Visual dealing with the serious condition of the GENERAL FUND.

1982-1983 Budgeted: \$65,000 Pledged: 58,000 (\$7,000) 1983-1984 \$75,000 60,000 (15,000)

The following points and consideration was this presented to the Board:

- 1. Our Congregation MUST see that the GENERAL FUND as a number one priority,
- 2. In certain situations the church is losin money (estimated \$3000)
 - a. by members leaving the church and not supporting us,
 - b. by low pledging from hing-income church members,
 - c. by not having a watchdog committee to oversee gifts and developing a gift giving strategedies,
 - .d. great misconception by church members that everything is rosy with the general fund.
- 3. The Church Membership must now realize that it is a small church, roughly 100 families.

A discussion was held by board members present dealing with the above items and also the following items:

- 1. A 5 year finance plan must be supplemented for a year to year program,
- 2. A policy needed for gifts over \$100-This should go directly to
- to the General Fund and should be in writing. This is for gifts that are not designated for special purposes.
- 3. Should there be a "GREATEST NEED" policy developed ???
- 4. Should the Financial and Budget Committee have the policy revised, rewritten and re-established: or would this be a BY LAW change? Discussion among all present board members was held and a general feeling was arrived at. That financial control be another high priority item. Another item discussed was the purge of the Deancon Roll. At this tiem a motion was made by Elmer Anderson and seconded by Glenn Johnston that a review, analysis and a defintie policy dealing with church giving be considered. Motion passed.

Stewardship: By Al Evans as noting the change of rame. Also would look into copier for church printing needs.

Worship: J. Huie thanked all for their help in the pass year. Christistian Service: Report read by Ival from Mary Alice Jayne. Education: Marge reported on a very successful Christmas gathering. Deacons: Mae Williams announced the following would serve for
