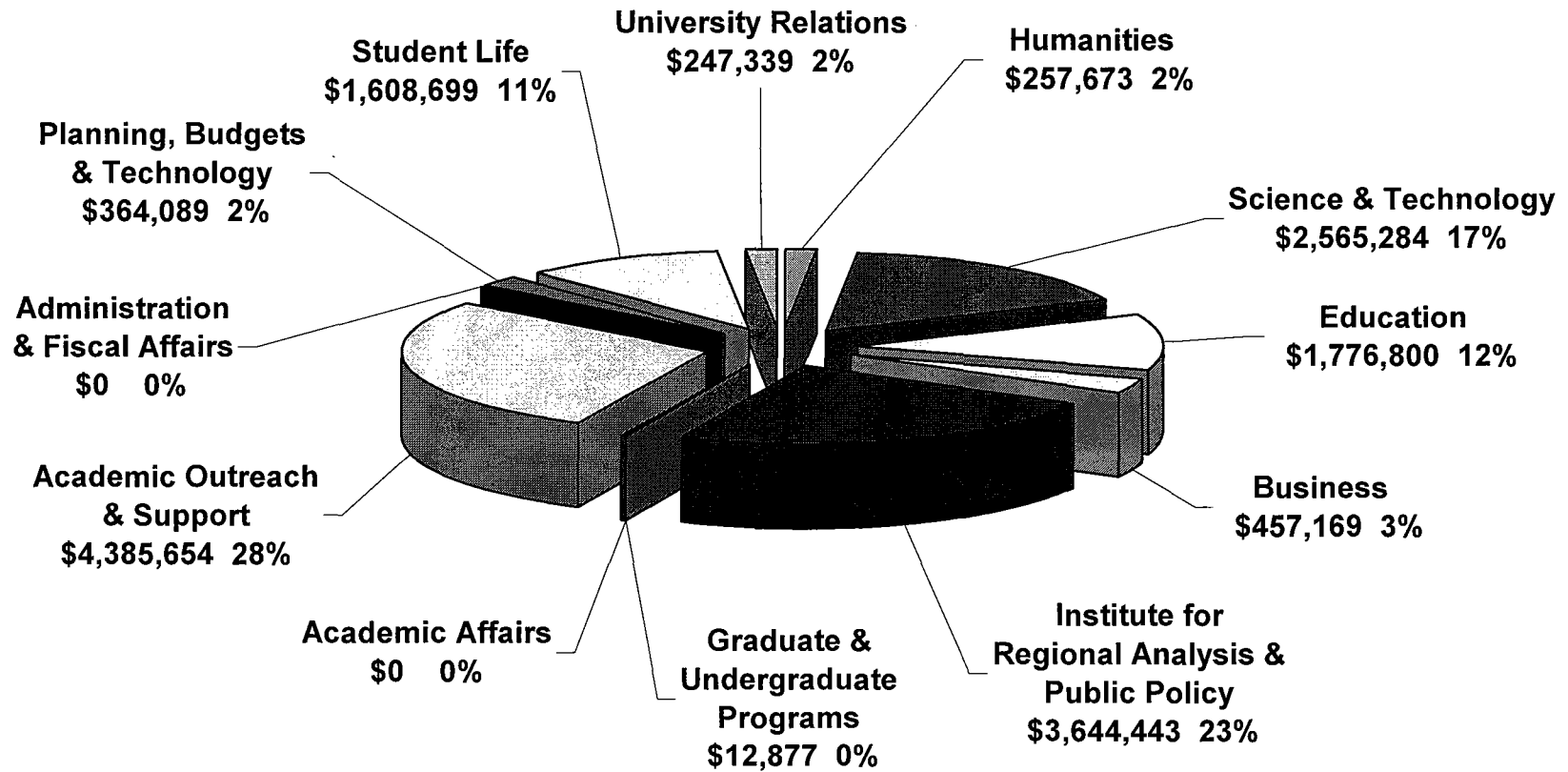

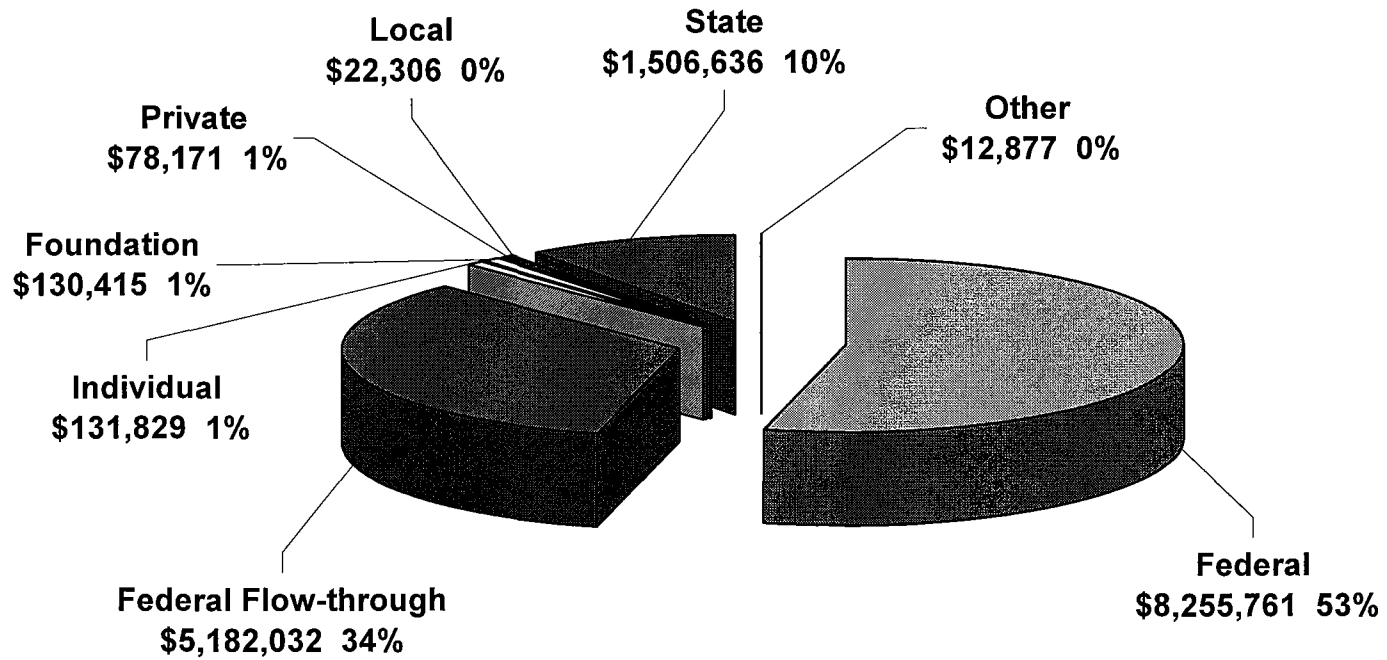

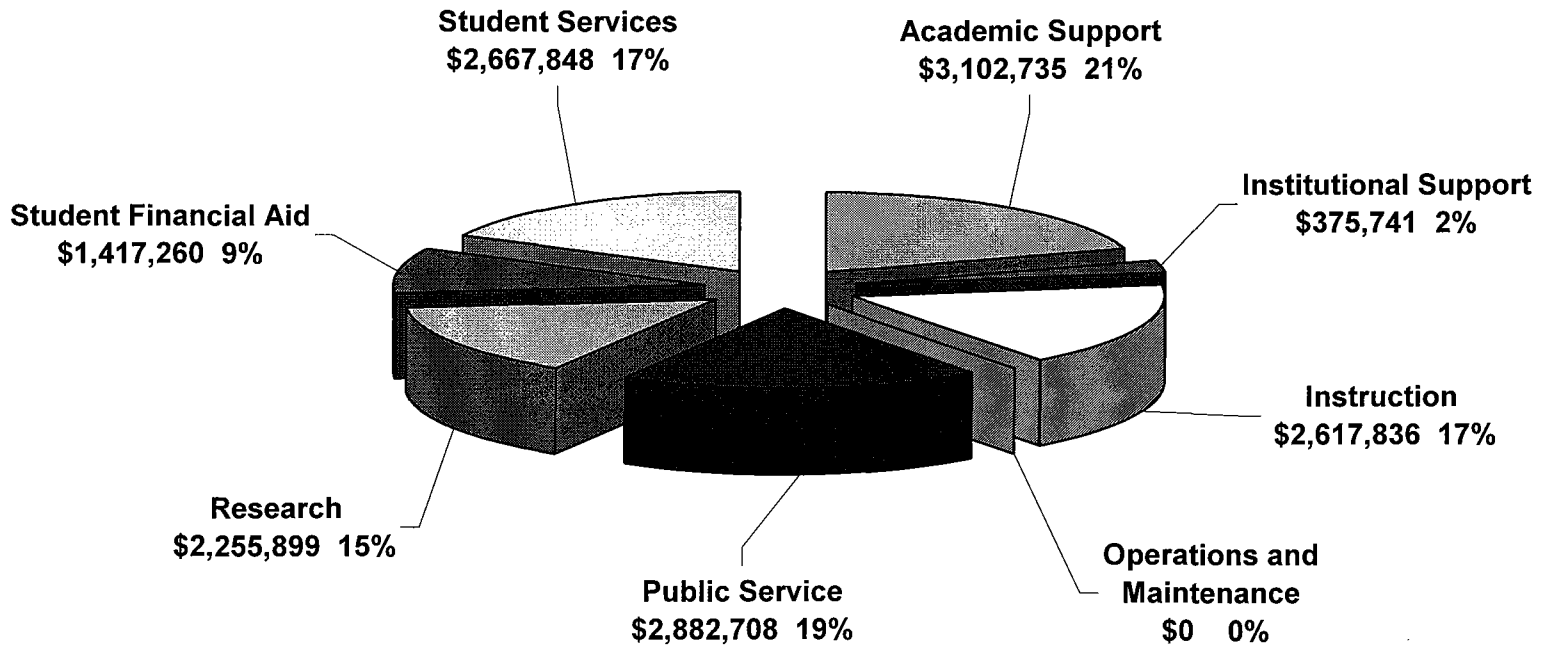


**PROPOSALS SUBMITTED DURING FY 2004-2005
