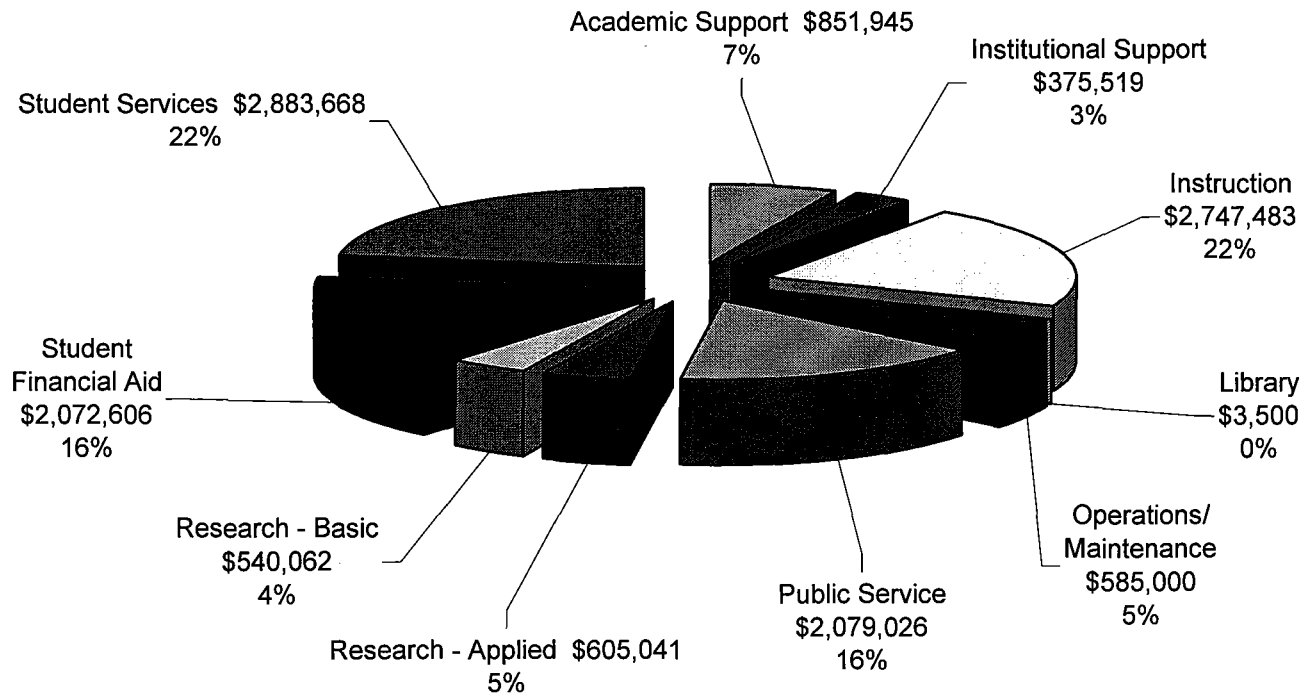

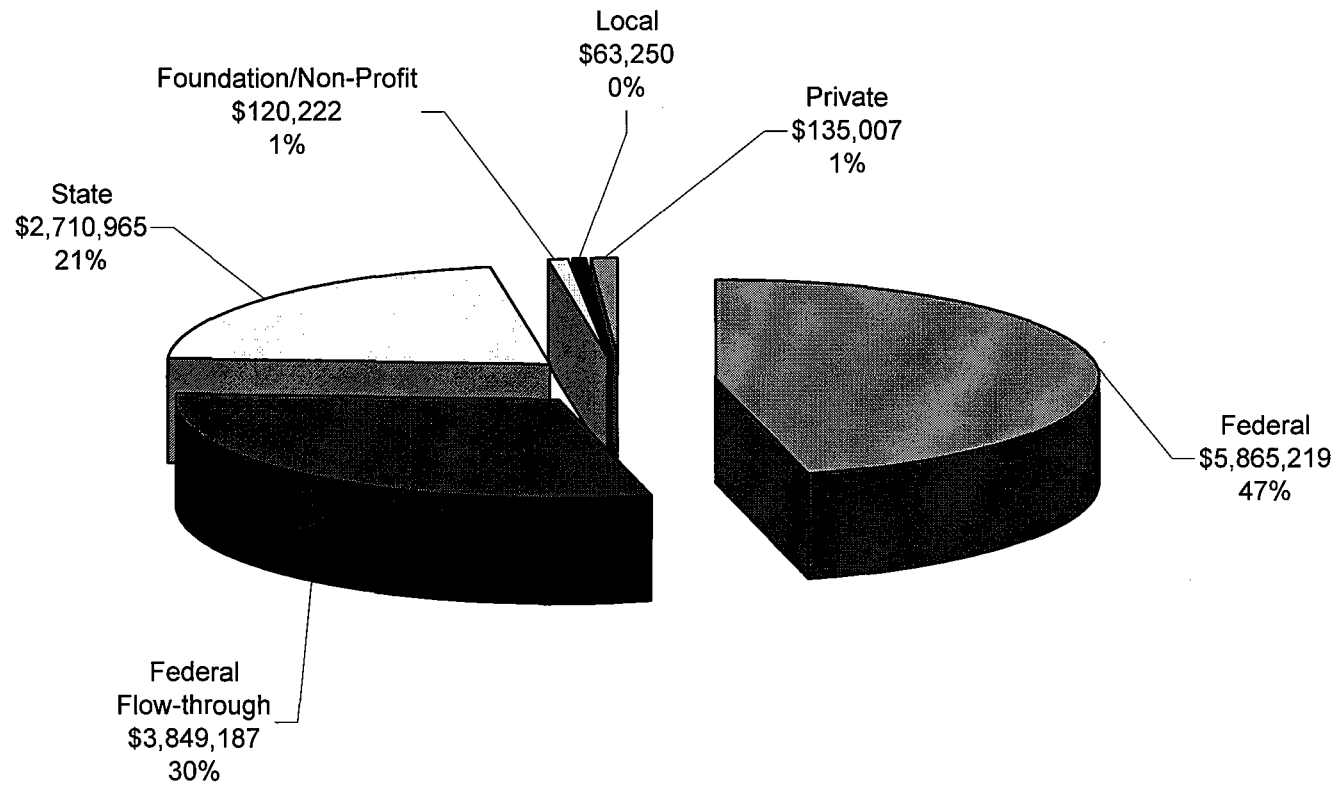
**SUMMARY OF FUNDED PROPOSALS
