Item III. Committee reports.

Property: Glen Buckner reported approval of this committee for a new roof for the Hogge property. The bid is from Curt Adkins Roofing for \$1125.00. Bid is for new roof, not removing existing roofing, as it is only one layer thick. This committee has also contracted Pat Johnson to build a bookcase in the pastors study. Cost complete, less staining, will be \$250.00. He also proposed the C.Y.F. be employed to sweep all walks around church property, weekly, and remove snow, as needed. He was asked by the board to get a cost on this and report back to the board. He and Cecil Landreth will be lighting the furnace in the property next door. He advised the board of the organ tuners recommendation to remove the decorative panels (total of 4) around the organ. They feel this is necessary to keep the organ in tune, and would save the church \$200 - \$300 annually.

Motion to accept recommendation of organ tuners to remove the 4 decorative panels around to organ, was made by Ron Walke, second by Glen Johnston, and carried by unanimous vote.

Education: No report

Worship: Fran Helphinstine reported the Advent Booklets are ready for distribution. Printing costs were \$88.50.

Motion to pay \$88.50 cost of printing Advent Booklets was made by Jack Bizzell, second by Chlo Calvert, and carried by unanimous vote.

Fran Helphinstine listed dates for decorating the sanctuary of Nov. 30, 1986 at 1:30 p.m. and Dec. 1, 1986 at 6:30 p.m. The decorations will be removed Jan. 2, 1986 at 1:30 p.m. She asked for help from all church people with this project. Generations will be represented this season with the lighting of the Advent wreath. The Chi Rho will be lighting the aisle candles and the candles on the communion table. Anyone wanting to order poinsettias to be used in the sanctuary should place their order with the church secretary as soon as possible.

This committee would like to change the order of worship to allow communion at the latter part of the service during the season of Lent.

Stewardship: Ron Walke reported a total of \$73,705.50 representing 130 estimate giving units as of 11-24-86. This is only \$16.50 short from last years Pony Express Stewardship Campaign.

Christian Service: Grace Cassity, there will be a special offering taken in December.

Social Action: No report

Long Range Planning: Tommy Griffith reported this committee along with the Executive Committee, Property Committee, and Social Action Committee, met and would like to recommend that the Human Concerns Office be moved to the brick building next door, and they be allowed to use the first floor, basement, and one room upstairs for storage. He recommended they use the back entrance only, and maintain the front of the building as to project a pleasing appearance from the front street. The Human Concerns office will paint the interior and be responsible for the utilities. The church will maintain the property. The committee further recommended the white frame house now occupied by Human Concerns be torn down, and the lot be graveled and used for parking. The garage/apartment is not a part of this proposal at this time.

Motion to accept recommendations of Long Range Planning and allow Human Concerns to move to the brick building was made by Jack Bizzell, second by Grace Cassidy, and carried, with one dissending may vote.

Prompted by decisions that had to be made last year by Tom Phelps. Interim Minister; Randy Wells. Property Committee Chairperson; and Jeanne Muie. Worship Committee Chairperson; you will find attached a proposed policy to replace the policy currently in the church file. I have no information which would indicate when the current policy was prepared or if the policy was ever accepted by the Church Board.

This working copy is offered to the Executive Committee for review with the following recommendations:

- after review and clarification by the Executive Committee the policy be accepted by the Board and dated;
- policy be supplied to all groups and committees using the church;
- 3. policy be reviewed in two years.

If you have any questions please contact me. I would be glad to present this to the Executive Board and answer any questions regarding recommendations.

Use of Building and Equipment

ADMISSION

1. Use of the church facilities, should be confined to religious, character building, and social service enterprises.

No group should be permitted to charge admission to any program held in the church Sanctuary.

Non profit groups will not be charged for use of church facilities. Offerings may be received.

All groups using church facilities will be responsible for leaving the church clean and in order.

Scheduling of events must be made through the church office with

consideration given regarding other acheduled activities and opening and closing of the building.

A copy of usage policy should be provided to each group using church facilities.

CUSTODIAL FEES .

2. Custodia! fees for weddings will be paid in advance to the church office. A fee of \$25 will be charged for the use of the Sanctuary and a fee of \$25 will be charged for the use of Fellowship Hall and kitchen.

Custodial duties must be coordinated with the janitorial staff.

DOMATIONS

3. Equipment of any type to be donated to the church must be cleared with the Property committee. Any donations related to the Sanctuary should be cleared through the Worship committee.

FUNERALS

4. The church will be made available without charge to any bereaved family; members and non-members alike.

KITCHEN

5. Permission to use the kitchen should be arranged through the church office.

Consideration must be given to the volume of kitchen activity needed.

Kitchen must be restored to order and left clean. All linens must be cleaned and returned to the kitchen promptly.

LENDING OF CHURCH PROPERTY

-6. No property of this church may be loaned to anyone unless parmission is granted by the Minister/Property committee/Worship committee. This includes all equipment, musical instruments, bells, choir robes, etc. Persons borrowing equipment will be held responsible for its care and prompt return.

NURSERY

7. Use of the Nursery should be allowed CNLY WITH WRITTEN PERMISSION. Consideration must be given to ages of children and adequent supervision to be provided because of church liability.

ORSAN

8. Use of church organ by outside individuals should be co-ordinated with Minister/Worship committee/Organist. Complexity of church organ determines usage by skilled individuals only.

SANCTUARY

- 9. The setting of the church Sanctuary should not be changed without consultation of the Minister/Worship committee/Property committee.
- 10. No tacks, pins, or any type of materials which will mar, scratch, or deface any of the Sanctuary can be used.
- 11. No decorations should be used which will deface church property. Objects such as flowers, placecards, candles, etc. must have standards, vases, or pans to support them.
- 12. Custodial fees will not be charged to groups unless extra-ordinary usages is required. (See policy for Weddings and Funerals)
- 13. Pew candlelabras (property of the church) may be used and if broken replaced by the individual.

SMOKING RULES

14. There will be No Smoking in the Sanctuary at any time. Smoking is permitted in Fellowship Hall.

WEDDINGS

15. Minister/Worship committee/Property committee should coordinate wedding plans for church usage. (See policy for areas of church needed) Responsibilies of church and individuals should be outlined in written form and kept on file in the church office.

The First Christian Church Amnual Meeting was held on July 20, 1986 at 7:30 P.M. The meeting was called to order by Chairperson Jack Whidden. Mary Jane Bowne opened the meeting with prayer.

TREASURER'S REPORT:

Alex Conyers presented the Annual Report for the first six months of 1986. Alex passed out a hand-out revenue section of the budget. Going into the church treasury this past six months was \$29,800, from the sale of the church parsonage. Four special offerings were collected. The Living Memorial Fund which has it's own accounting annunity is \$29,895 of which \$15,000 has been disbursed on a loan to Harold and Barbara Tackett. From the proceeds from the sale of the parsonage, \$29,000 has been placed on loan of the cash in the Living Memorial Fund with \$15,000 - total of \$44,000 at 11% interest rate. The Board of Directors approved the establistment of a N.O.W. Account/Money Market Account. As the principal and interest is paid by the Tackett's on the money that was borrowed by them, which represents the proceeds from the sale of the parsonage is collected it will be placed in the N.O.W. Account waiting a more permanent investment.

Alex suggested in the future the Church consider a professional manager to help in directing the usage of Church Funds.

A breif description was presented in regard to the hand-out. At the end of the first six months of 1986 there is \$5,000 cash balance in the bank.

STEWARDSHIP: Paul J. Reynolds thanked the Pony Express Committee and Glenn Buckner who served as Chairman of the Pony Express, for the great job the committee provided the church.

EDUCATION: Marge Thomas stated the committee secured Sunday School Teachers, helped present the Christmas program, and Sunday evening Santa Claus program. In the fall the committee recognized the Sunday School Teachers and presented them with a gift. Edith Conyers purchased for the committee gifts which were presented to the graduating seniors from the

congregation. The committee had a very successful Vacation Bible School in July. Sunday School Teachers have been secured for September through February.

WORSHIP: Jeannie Huie reported that the committee worked on seasonal decorations, the canta, and decorated the church for Christmas season. The committee is working on a Church Usage Policy. A special thank you to Myron Doan and Sarah Chaney in the great job they perform for the worship service.

CHRISTIAN SERVICE: Glenn and Eva Johnston are cochairpersons. Glenn noted the following offerings: Week of
