### BRIEF DISPATCHES

#### THURSDAY—

The revolutionary movement in Hayti has collapsed, according to official reports.  
Joseph Albin Fayard, the dean of the French senate, is dead. He was born in 1816.  
Five destroyed thirteen buildings in the village of Kinball, W. Va. The loss is estimated at \$50,000.  
The pension bill, which, if ratified, will increase the pension roll by about \$12,500,000, has been introduced in the house.

#### FRIDAY—

The anniversary of the birth of the late President McKinley was observed by the Ohio general assembly with appropriate exercises.  
Senator Hopkins has introduced a bill to amend an act relating to the constitution of the United States.  
Secretary of Agriculture Wilson was re-elected president of the American Breeders' association.  
The sixth international congress on tuberculosis will be held in Washington, Sept. 21 to Oct. 3, 1908.  
An official of the Krupp gun works has been arrested at Essen on the charge of betraying military secrets to the United States.

#### SATURDAY—

The Rock Island station at Topeka burned, entailing a loss estimated at \$100,000.  
There are widespread reports of large numbers of unemployed in all sections of the country.

## From G. W. WILHOIT

DOUGLAS, ARIZ.

Jan. 25, 1908.

In my first letter I tried to give you some of our observations en route to this place and promised you a letter about this city and surrounding country, provided my first one escaped the wastebasket.

On our arrival in Douglas we expected to find only a small border town with but a few houses but fancy our surprise when, on alighting from the train we were met by at least a score of hotel omnibuses, automobiles and baggage transfers, all anxious to take us somewhere for small remunerations.

We arrived at 3 o'clock P. M. on Saturday and began keeping house on Tuesday following.

Douglas is located in the South East corner of the Territory, on the boundary line between U. S. and Mexico. It is in the Sulphur Spring Valley in that part of the Territory known as the Gadsden purchase. This purchase was made in 1853 by the noted Diplomat of that name and like the Alaska purchase it has taken years for the people to realize the wisdom of this real estate venture by Uncle Sam.

Several years ago when Arizona was fighting for Territorial Rights, U. S. Senator, Ben Wade, of Ohio, said in a speech in the United States Senate, that the needs of Arizona and Arizona were identical. All either needed to become a good community was water and good society, but Arizona has forged ahead of the other places in as much as she has both water and good society and is consequently a good country.

Douglas was founded in 1900 and consequently is hardly thirty years old at this writing, still it has a population of 12,000, the latest city directory just published and has every public utility found in any city of five times its size. Every leading religious denomination is represented here, both by church organization and church edifice. Douglas has a fine library building stocked with a great assortment of choicest literature. It has two large hospitals to care for the sick.

The above library and hospitals were given the city by the C & A and the Copper Queen Smelting Companies, who have done much to build up Douglas than all other sources combined.

This city is well supplied with stores and hotels. Stores here will compare with any to be found in any town of fifty thousand population. One large department store here has ten departments and employs one hundred salesmen and saleswomen. There are more than a score of hotels in town, the leading one, of which cost to complete was \$18,500, is named The Gadsden and is fine as any to be found in the Southwest. There are about fifteen saloons here I have not seen but two men that I could tell were under the influence of liquor since I have been here. I have not seen a pistol since I have been here, neither have I seen a man arrested or under arrest, but I am told that this condition does not hold good all over the Territory.

Sulphur Spring Valley is high plain almost as high as the clouds, Douglas being 4,000 feet above sea level, the air is very light and has very little or no moisture which makes it very healthful for persons suffering from pulmonary troubles. But for the same reason it is a place where pneumonia is very prevalent, people sometimes have pneumonia here during the months of July and August but not often.

The land throughout this valley is very fertile and when water is applied to it the very best results are obtained but the mountains being low with no vegetation on them there are no running streams here where one can get water for irrigating purposes. (Continued on next page col. 4)

## Washington News.

President Roosevelt this week undertook to stir up Congress by a message calling attention to a number of pieces of legislation badly in need of attention. Truth to say the message was cheered at the Capitol more by the Democrats than it was by the Republicans. It was a good stirring message, and it could be taken in two ways according as the hearer was of Roosevelt or anti-Roosevelt tendencies. Either way it was a good campaign document, and there was an order for an immediate edition of 12,000 printed.

The message was prompted first of all by the action of the Supreme Court recently in denying the legality of the Employers Liability Act. It was to the need of legislation on this subject that the President called chief attention. He urges the re-enactment of the law, limiting its scope so as to bring it within the limits of the Constitution. In the same connection he urges the passage of a comprehensive act providing for the compensation of employees in the government service injured in the line of duty. Action is also urged against the "abuse of injunctions in labor cases." Another section calls attention to the necessity for legislation to give better control over corporations engaged in interstate business. A certain measure of federal control over the physical operations of the railroads is also urged. The suggestion is made that the use of the mails, telegraph and telephone service might also be denied to gamblers in stocks and futures, but the President admits that this is a hard matter to handle and will require careful regulation if regulation at all is possible. Finally he urges the fullest power for the Department of Justice in dealing with large corporations.

The President in dealing with the Employers Liability Act points out that the Supreme Court admitted the constitutionality of the law so far as it dealt with persons engaged in interstate business, and rejected it only on account of its application to intrastate concerns. He says "I urge the immediate re-enactment of the law, limiting its scope to the class of business to which it can legally apply, but strengthening its provisions within that scope. With this clear definition of responsibility, the several states will doubtless give to the subject within their jurisdiction the consideration that its importance deserves."

As to the responsibility of the government, the message says "I also urgently advise that a comprehensive act be passed providing for the compensation by the government of all employees injured in the government service. Under the present law a workman injured in the service of the government has no remedy and the entire burden of the accident falls on the helpless man, his wife and his young children. This is an outrage. It is a matter of humiliation to this nation

that there should not be on the statute books provision to meet and partially atone for cruel misfortune when it comes to a man through no fault of his own while faithfully serving the public. In no other prominent commercial country of the world could such gross injustice occur for almost all civilized nations have enacted legislation embodying complete recognition of the principle that places the entire trade risk for industrial accidents on the industry as represented by the employer, which in this case is the government."

In pointing out why this is a fair arrangement, the President says that if the wage system were ideal, then the wages would be apportioned to cover these trade risks, and if all men were wise they would insure themselves with part of their wages against these risks. But neither of these ideal conditions exist and in their absence, the only thing to do is to make the employer responsible for the risks necessarily run by the employees.

Naturally the President refers to some of the attacks that have been made on the administration and the charges that it is responsible for the present business depression, but he says not only is the charge groundless but that there is no reason for any misgivings as to the future. He says: "We have just passed through two months of acute financial stress. At such a time it is a sad fact that a great many innocent people who suffer through no fault of their own, and every one must feel the most acute sympathy for them. At such a time there is a natural tendency on the part of many men to feel gloomy. But there is no justification for this feeling. There is no nation so absolutely of ultimate success as ours. Of course we shall succeed. Ours is a nation of masterful energy with a continent for its domain and feels within its veins the thrill that comes to those who know they possess the future. We are not cast down by failure. We are upheld by the knowledge of ultimate triumph. The wrongs that exist are to be corrected, but they are not to justify doubt as to the final outcome. I do not for a moment believe that the actions of this administration have brought on business distress. So far as this is due to local and not world wide causes, and to the action of particular individuals, it is due to speculative folly and the flagrant dishonesty of a few men of great wealth who seek to shield themselves from the effects of their own wrong doing by ascribing its results to the action of those who have sought to put a stop to the wrong doing. But if it were true that to cut out rottenness from the body politic meant a momentary check to an unhealthy seeming prosperity, I should not for one moment to put the knife to the corruption. On behalf of our own people it is necessary to insist on honesty in business and politics alike, in all walks of life, in big things and in little things

upon just and fair dealing as between man and man. Those who demand this are striving for the right in the spirit of Abraham Lincoln when he said: "Fondly do we hope and urgently do we pray that this scourge may speedily pass away. Yet if God wills that it continue till all the wealth that has been piled up by 250 years of unrequited toil shall be sunk, and every drop of blood that has been drawn by the lash shall be paid by another drawn by the sword, then shall it still be said as it was said three thousand years ago: The judgments of the Lord are true and righteous altogether. Therefore with charity toward all and malice toward none, let us strive on to finish the work we are in."

## Doings In The Hall of Our Legislature.

Frankfort, Ky., Feb. 4.—Another week has passed and the senatorial race seems to nearer a solution than it did three weeks ago. The deadlock still holds firm and unless the temperance question can out the Gordian knot there is no prospect of an election at this session of the legislature. The temperance fight has already fluted into the senatorial race, however, and may be the one thing that will cause an election.

majority of them, try to pass this bill. It is asserted that these members will vote for and elect the Republican nominee for senator. If the Republicans vote and work for the equity bill, then the temperance men will not vote for the Republican nominee. The liquor men seem to hold the balance of power and want to side it to further their interests. They are opposed to Beckham because of his temperance views, but they do not want to vote for Bradley unless the temperance men give a course. That is the situation now, and if anyone can guess what will happen he can do more than any man in Frankfort.

Senator Hubble of Lincoln county has introduced a bill in the senate which requires all legal reserves. He insurance companies doing business in Kentucky to invest 80 per cent of the reserve on all standard policies issued in Kentucky, in Kentucky securities, such as state, county or city bonds, mortgages on real estate and mortgages on tobacco that is pooled by some of the temperance bills which is operated in the interest of the tobacco growers. The primary object of the bill is of course, to prevent the enormous reserve funds of the life insurance companies from being held and invested in New York alone. The Kentucky legislature has no control of these insurance companies, it is true, but it can pass a law to the effect that no company can do business in Kentucky unless it invests a part of the

reserves in Kentucky securities. A similar bill with the tobacco feature left was introduced in the legislature two years ago, but the influence of the insurance companies smothered it. It will be quite a feather in Senator Hubble's cap if he can put his bill through, and thus help the tobacco raisers bring the tobacco trust to terms.

Judging from the number of bills introduced, the members of this legislature are anxious to do something for both the living and the soldiers. Senator Henker has offered a bill providing for a pension of \$125 per year for all disabled and indigent Confederate soldiers, and Senator Hogan of Ford county has introduced a bill amending the law governing the Confederate Home so that a Confederate soldier who is entitled to become an inmate of the home may if he chooses remain with his family and draw the amount for his support that would be paid for his maintenance at the home. The bill is appropriate \$25,000 for a monument or memorial to the Confederate and Union soldiers at the Vicksburg National park, Vicksburg, Miss., has already been approved by the senate committee and will likely pass without any serious opposition. This is considered a small amount when compared with the \$200,000 appropriated for the same purpose by Illinois, \$200,000 by Iowa, \$100,000 by the Rhode Island, and similar amounts by many other states. Kentucky was represented by twelve regiments at the siege of Vicksburg, including both the Union and Confederate forces, and she should not be behind the other states in paying fitting tribute to her brave sons that fell on that famous battle ground.

Several bills have been introduced this session to make eight hours a legal day's work for several different classes of laboring men, but the legislature itself has much shorter hours than that. As a matter of fact the legislature does not learn how to work till the last three weeks of a session. For the biggest part of the sixty-day term they just loaf along and take things easy. They meet about 11 o'clock in the morning, go through with some unimportant routine work till noon, then take a ballot for United States senator and adjourn for the day. It is true that some committee meetings are held in the afternoon and at night, but so far this year the senatorial race seems to have demoralized all attempts to get down to hard work. It has been suggested that better results could be obtained if the legislators were paid a fixed salary for their full term instead of the five dollars a day they now receive. Senator Nat Cronin of Louisville has offered a bill providing that all legislators shall receive \$40 per month for their full two-year term, and the lieutenant governor to receive \$2,500 per year. It is not believed that this bill will pass, and if it should pass it would not apply to the present legislature, as the salary of an official cannot be changed after he has entered upon his duties.

One of all the bills introduced looking to the securing of a better system of public roads. It is believed that some one good measure will be adopted. The constitution does not permit state aid to road-building, but state aid seems to be the only solution of the problem. With this idea in view, Senator Howarth has introduced a bill providing for a vote on the proposition to amend the constitution that the state may lend its credit to any county to help that county build good roads. The plan is to have a

county vote to issue bonds for a certain amount to build roads, and then the state will endorse the bonds, and thus the money will be carried on the work. Other states have even gone farther than this. In New York the state contributes 50 per cent of the cost of all such. California and Colorado pay all the cost. Massachusetts pays all the cost, but requires the counties to refund one-half in six years. In Ohio the state pays 25 per cent, the county 50 per cent, the townships 15 per cent and the abutting property owners 10 per cent. In Pennsylvania the state pays 75 per cent. A large number of other states will feel the counties to a greater or less degree, to build the roads, and unless some measure is adopted by the legislature to promote road-building, Kentucky will soon drop behind her sister states and be known as the "mud-road state."

Kentucky has neglected her fish and game laws for so long or has failed to enforce them, that fish and game have almost become things of the past. Other states have rigid laws on this subject and enforce them to the letter, but it has never been done in this state. In fact, there is an attempt at every session of the legislature to repeal the few restrictions as to fishing and hunting that are now on the statute books. Representative Hunter of Clark county has introduced a bill providing for the appointment of a state game and fish commission, that shall create a game warden. The bill further provides for a gun license for all hunters of \$2 for pump or repeating guns and \$1 for other guns. It also provides for a license of \$1 for every fisherman who is a resident of the state and \$5 for all non-residents, and limits the amount of game and fish that may be taken in any one day.

Representative W. C. McChord of Washington county has offered a bill that he thinks will to a great extent solve the tobacco problem of this state. This bill provides, first, that all persons, companies, corporations or governments that are engaged in manufacturing or buying tobacco in this state must first procure a license to do so from the state commissioner of agriculture; second, it provides that it shall be unlawful for any person engaged in growing tobacco to put any growing plants any poisonous substance for the purpose of destroying worms or insects for any other purpose; third, it makes it unlawful for any person having the possession of tobacco, the title of which is vested in another, to sell or otherwise dispose of such tobacco without the consent of the person in whom the title is vested. The latter clause is to prevent anyone who has pooled his tobacco from taking it out of the pool and selling it to the "trust."

About the first bill to pass the senate was the Howarth bill, which authorizes, under certain conditions and restrictions, the use of the public highways, roads and turnpikes by persons, firms or corporations engaged in the manufacture, transmission and distribution of electricity for lighting, heating and power purposes. The conditions are that the title of the highways of the said companies shall not in any way interfere with travel on public roads and the said transmission lines shall be under the reasonable control of the authorities having control of the roads. Nothing in the act shall be construed to prevent the property owners from obtaining damages for such rights, and the act shall not apply to any incorporated town or city.
