

MINUTES OF MEETING OF BOARD OF REGENTS  
OF MOREHEAD STATE TEACHERS COLLEGE HELD  
IN OFFICE OF SUPERINTENDENT OF PUBLIC  
INSTRUCTION, FRANKFORT, KENTUCKY,

JULY 8, 1940.

A meeting of the board of Regents of Morehead State Teachers College was held in the office of the Superintendent of Public Instruction, Frankfort, Kentucky, on July 8, 1940 at 2:00 P. M., pursuant to the call of the Chairman, J. W. Brooker.

The following members were present:

Mr. Donald Putnam was unable to attend and a letter of regret was read from his secretary. Dr. W. H. Vaughan, President of Morehead State Teachers College, was also present. In the absence of the Secretary, Mr. Putnam, Miss Clara Kershaw of the Department of Education was requested by the Chairman to serve as Secretary pro tem.

The meeting was called to order by Chairman Brooker. At this point Mr. Ramey called to the attention of the Board a matter of unfinished business from its meeting of April 30, namely, the question of the election of former-President Babb as President Emeritus of Morehead State Teachers College, and requested that some action be taken on this matter at this meeting. This being agreeable to the Board, Chairman Brooker read from the minutes of the meeting of April 30, the following:

It was moved by Mr. Ramey, seconded by Mr. Putnam, that Mr. Babb be named as President Emeritus of Morehead State Teachers College, effective July 1, 1940, the period and amount of compensation to be determined by the Board.

Mr. Brooker declared the motion was in order, and there being no discussion, called for a roll call vote, which resulted as follows:

The motion was declared lost.

Furnishing steam: President Vaughan presented the request of Dr. A. F. Ellington that the College furnish him with steam, and after a general discussion, it was the consensus of opinion that the College should not undertake to sell steam to an individual, and no action was taken. It was moved by Mr. Shannon, seconded by Mrs. Young, that Mr. Ramey, Mr. Putnam and Mr. W. H. Rice be named a committee of three to study the contract between the Morehead State Teachers College and the Kentucky Utilities Company, with power to act for and on behalf of the Board. The motion was put, all voted "aye", and it was so ordered.

Alleged damage to certain properties. The question of pending suits against the College and the Commonwealth of Kentucky for damage allegedly done to certain properties by the overflows from the dam during the floods, was presented to the Board by President Vaughan. Assistant Attorney General Keller was called in to the meeting, and after a lengthy discussion it was decided that no action should be taken by the Board with reference to these claims, and upon motion of Mr. Ramey, seconded by Mrs. Young and unanimously carried, Mr. Shannon was appointed a committee of one to work with General Keller and the Governor to see what could be done to effect a permanent solution of the problem. General Keller then retired from the meeting.

Cafeteria. - President Vaughan stated to the Board that the management of the College cafeteria was not entirely satisfactory and suggested that a competent person be employed and placed in charge of the cafeteria. Mr. Shannon stated that Mrs. Brown, who was experienced in work of this kind, was in Frankfort and that he would like for her to meet the members of the Board. There being no objection, Mrs. Brown was invited to appear before the Board. She stated that she was interested in cafeteria work and would be delighted to meet with President Vaughan to go over the College cafeteria and work incident thereto with him at the earliest opportunity. Mrs. Brown then retired from the meeting. It was moved by Mr. Ramey, seconded by Mrs. Young, that President Vaughan be directed to interview and investigate persons who might be interested in serving as manager of the College cafeteria, and make recommendation to the Board at a subsequent meeting. The motion was put, all voted "aye", and it was so ordered.

College Theatre. President Vaughan then called to the attention of the Board to the fact that the College theatre had outlived its usefulness and recommended that same be discontinued. After a general discussion, it was moved by Mr. Ramey, seconded by Mrs. Young, that the College picture show be closed. The motion was put by the Chairman, all voted "aye", and it was so ordered. President Vaughan stated that the equipment would be kept and used for educational purposes.

Home Economics Department. Motion was made by Mr. Ramey, seconded by Mrs. Young, that President Vaughan be authorized to build up the home economics department to meet fully the requirements for training of Smith-Hughes teachers. The motion was put, all voted "aye", and it was so ordered.

College library. President Vaughan stated that it would be necessary to strengthen the College library in order that it might properly meet the needs of the students. Motion was made by Mr. Ramey, seconded by Mrs. Young, that the President be authorized to employ an assistant librarian and to purchase carefully selected books, at a cost of \$1200 per quarter, for the College library. The Chairman asked for a roll call vote, which resulted as follows:

Faculty for 1940-41. - President Vaughan then presented his recommendations relative to the faculty for 1940-41. After a general discussion, it was moved by Mr. Ramey, seconded by Mrs. Young, that the following teachers recommended by President Vaughan be elected for the school year 1940-41, at the salaries indicated. The Chairman asked for a roll call vote, which was as follows:
