### COMPARES TWO CANDIDATES.

Democratic Ability of Mr. Taft Contrasted With the Weakness of the Democratic Leader—Progressive Conservation Versus Radicalism.

My Dear Sir—You are now of age and about to exercise the right of an American citizen for the first time. You were brought into the world to which party to ally yourself with, and have asked my advice upon this point. I will impart to you my own feelings in the matter.

Democratic party and have long recognized the wisdom of its measures and both the sincerity and ability of certain of its leaders. I have, however, never hesitated until the present session to give it my unqualified support, for, while disliking Mr. Bryan and heartily disapproving a platform devoted to the free and unlimited coinage of silver at its own expense, and a gold standard, I nevertheless remembered my party loyalty and voted the Democratic ticket. For the same reason I voted as I had always done in the election of 1900, though I was in sympathy with the Democratic platform then, before and thoroughly convinced that the majority of the American people would in the long run entirely approve the action of the Republican administration in liberating Cuba and the Philippines from the shackles of Spain, in developing their resources and in governing them wisely and firmly until such a time as they should be enabled to stand upon their own feet.

When in 1904 Mr. Parker received the nomination of my party, I entertained lively hopes that he would fill upon a man who would unite the conservatism of the old with the progressiveness of a new Democracy. You will perhaps recall how bitterly I was disappointed, both in the make-shift policy of the party and in the bloodless character of the man.

After the overwhelming defeat of 1904 I gradually awoke to the fact that I was almost totally out of sympathy with the controlling forces in my party and began to feel something of a distrust for the advocates of Populism, Bimetallism, Imperialism and radicalism. I am of the opinion that the Democratic party cannot hold its conservative and its Socialist at the same time. The bonds were bound to break, and have done so. Feeling the lack of a leader, thousands of the moderate wing of the Democratic party have flocked to the Republican standard. I have witnessed how states become Republican which had always been staunchly Democratic. This will undoubtedly be true of Kentucky and Tennessee, and I should not be surprised to see Georgia and Florida following in their lead.

In looking over the platforms of the two principal parties I have been able to discover so little dissimilarity and hardly in all of the more vital measures that I again feel strongly that the chief distinctions will be a question of more rather than of issues and of this I advise you to scrutinize the characters and careers of the respective candidates with the greatest care.

Both are men of the highest personal character and irreplicable in private and personal qualities. The crucial test is in the showing of their qualifications for public administration of large affairs and in their perception of the true public interest in the issues of the day. Such a test and such a comparison, it seems to me, are greatly

### Yokohama Gives Warm Welcome to American Visitors.

Yokohama, Oct. 13.—Yokohama is a place of color, with American and Japanese flags flying from every building in honor of the delegation of Pacific coast business men who arrived on the Japanese liner Tenryo Maru from San Francisco. The visitors were greeted at the dock by a crowd which numbered hundreds of representative business men of the city assembled from the cities of Tokio, Kyoto and Osaka. The carefully prepared program of entertainment for the American visitors will be completely filled with receptions and sight seeing trips arranged for them by their Japanese hosts. On Thursday the Americans will be greeted by Count Konuma, minister of foreign affairs, at luncheon given in honor of the visitors.

### ILLINOISIAN BEST PLOWMAN

Drives Over Half Acre and Furrows Show Little Variation.

Joliet, Ill., Oct. 13.—At the thirty-first annual plowing match of Illinois, held on a farm near here, Alvin Stark was proclaimed the champion of the world. Stark drove a single sulky plow with three horses over half an acre.

The judges declared there was not a variation of half an inch in the furrows measured at the ends and the middle. Cyrus Stark, a brother of the winner, previously held the record for six years.

### LOUISVILLE IS CUT OFF

First Time in Twenty Years, No Cincinnati Packet Service.

Louisville, Ky., Oct. 13.—For the first time in twenty years Louisville is entirely cut off from packet service with Cincinnati on account of low water. When the Louisville & Cincinnati Packet company took the Kentucky out of the running it brought about this almost unprecedented condition in the history of navigation on the Ohio river. Louisville has been without service with lower river points for several weeks.

### Heavy Loss in Florida Town.

Panacea, Fla., Oct. 13.—News of a disastrous fire which swept over Canabie, Fla., a small town east of Panacea was brought to this city by the steamer Tarpon. Nine business houses, a residence and many thousands of feet of lumber were destroyed, entailing a loss estimated to be more than \$100,000. Among the buildings destroyed were the United States custom house, postoffice, freight and passenger depots of the Georgia, Florida & Alabama railroad, and the warehouses and wharves of the St. Andrews & Gulf Steamship company.

ORGANIZED LABOR FOR TAFT

All That the Law Abiding Wage-Earner Asks For is a Square Deal, and He is Sure of It From President Taft.

FARMERS AND RURAL FREE DELIVERY

This Admirable Feature of the Postal System is a Creation of the Republican Party and to a Great Degree Aligned Why the People Aways Vote It Back in Power.

The Republican principle that the benefits of the public service should, as far as possible, be extended to all classes and all communities without discrimination, has been extended to the rural free delivery system instituted by the Postoffice Department during the administration of President McKinley.

The development of the rural free delivery service is one of the most remarkable achievements of the Postoffice Department since its organization in 1879 as an experiment with delivery on eight-three routes.

The value of this service to the farmer is almost incalculable. It has not only relieved them of the discomfort of long journeys to distant postoffices, but has helped them in close reach with market conditions, thus enabling them to dispose of their products to the best advantage, and done much to promote the neighborhood and village spirit.

Moreover, in scores of farming communities, the rural free delivery service has given a powerful impetus to the "good roads" movement, with the result that many thousands of miles of improved highway have been constructed.

The farmers know that the rural free delivery service is a feature of Republican policy. They are perfectly aware that it was devised by and in accordance with the Republican statesmanship which has provided cheap postage, encouraged the spread of education and endeavored every measure of existing law to maintain the dignity and advance the welfare of the farmer.

Mr. Dodge demonstrates from the records of the Treasury Department that ninety per cent. of all tariff duties are paid upon articles classed as luxuries consumed by the rich, leaving little, if any, of these duties to be paid by the great mass of people who are classed as the wage earners and farmers.

This information is particularly interesting at this time when Mr. Bryan and his followers are asserting that "the poor are oppressed by the tariff taxes" and "the masses are bowing down under the weight of tariff taxes upon the necessities of life."

The following table compiled from Government records for 1904-1905 shows Tariff Facts.

Such classes are fine linen, oxen and other valuable stores; fine machinery, etc. from which the revenue increases the "luxury" budget to about \$230,000,000—that is, ninety per cent. of the total external revenue.

# War Veterans And Pension Legislation

It has never ceased to honor the officers and men who composed the victorious army. **Republican Pension Legislation.**  
 Republican legislation for the old soldier, his widow and his minor children has been earnest and bountiful. The invalid pension law of March 14, 1862, and the dependent law of June 27, 1890, are monuments of Republican achievement and bear witness to the country's tender care of its soldiers and its sailors and their families.

The act of June 27, 1890, is a fitting illustration of the generosity of the Republican party toward the veterans of the Civil War. This law was passed by a Republican Congress, was signed by a Republican President, and through its administration there was paid out during the next fiscal year a total amount of \$48,793,560.17. The number of soldiers receiving the benefit of this law was 443,721, while the number of the dependents relieved by this law was 171,268. The gains in the number of pensioners under this act over the previous year was 160,000 and the gains from June 30, 1890, to January 5, 1904, was 492.

## Democratic Opposition Record.

The Democratic party, as such, has opposed every measure voting appropriations for pensions. At the close of the past forty years is one of opposition to those men who bore the hardships of war and who are now old men who live in the United States or abroad. Here is a brief list of their official adverse acts in Congress toward the veterans of the Civil War:  
 In 1878 a bill was introduced for repealing all limitations of time in which applications for arrears of pensions should be made and which was proposed by a majority of the Democrats.  
 The bill increasing the pension for widows from \$12 to \$12 per month was opposed by the Democrats and voted for solidly by the Republicans in the House.  
 The widows arrears bill which authorized pension bill were both fought bitterly by the Democrats.

 An effort was made in the House to pass the bill over Cleveland's veto. The Republicans voted 138 for it and the Democrats voting 125 against it.
