Minutes Read and Approved: On motion duly made and seconded, all voting Aye, the minutes of the meeting of the Board of Regents held April 11, 1942, were read and approved.

Appointment and Qualifications of Mrs. A. W. Young and Donald H. Putnam as members of the Board of Regents: Mrs. A. W. Young and Donald H. Putnam presented their commissions from Hon. Keen Johnson, Governor, to succeed themselves as members of the Board of Regents. Thereupon Mrs. Young and Mr. Putnam each took the oath of office as a member of the Board of Regents. The Commission of Mrs. Young is dated June 3, 1942, for a term ending April 1, 1946. The commission of Mr. Putnam is dated June 3, 1942, for a term ending April 1, 1946.

Minutes of July 29, 1942, continued - -2-

Settlement of Claim of Joseph and Joseph for Engineer's Fees: President Vaughan presented report of Mr. Wm. H. Rice and himself as a committee appointed at the meeting of the Board held March 6, 1942, to study and make a report on the claim for engineering services presented by Messrs. Joseph & Joseph. On motion duly made and seconded, it was ordered that the report of the committee be approved.

On motion of Mrs. Young, seconded by Mr. Shannon, the following resolution was unanimously adopted:

"It was resolved that the Board authorize the following payments to Messrs. Joseph and Joseph:

1. The sum of \$1,081.26, being 6% on \$18,021.00, work for which Mr. Joseph gave supervision and drawing plans.
2. The further sum of \$414.48, being 3.6% on \$11,513.32, representing work now completed for which Mr. Joseph drew plans but did not give supervision.
3. 3.6% on the additional cost of work to be performed on the Power Plant Dam, Spillway and Roads.

The above amounts to be in full payment, settlement and satisfaction of any and all claims whatsoever, and of every kind and nature for the services of Messrs. Joseph and Joseph for drawing plans, preparing and submitting estimates, and handling negotiations with Works Progress Administration, and supervision of work on the Power Plant Dam, Bridge and Roadways, covering all work previously done and to be done by said Messrs. Joseph and Joseph in connection with the said projects."

Re - Settlement of Claim of Judge E. C. O'Rear for Legal Services: President Vaughan reported that check for \$1,000.00 to be issued to Judge E. C. O'Rear in full settlement of his claim for legal services in connection with the Bradley cases, as authorized at the meeting of the Board held March 6, 1942, had not cleared through the Department of Finance, Frankfort, Kentucky; that before release of the check, the Department of Finance had requested an opinion from the Attorney General with respect to the legality of this payment.

Bill of James Clay, Attorney, fee for Legal Services in Bowling Case: On motion duly made and seconded, all voting Aye, President Vaughan, Donald H. Putnam and I. A. Noce, Jr., were appointed as a committee to look into the matter of the bill presented by James Clay, Attorney at Law, for services in the case of Bowling vs. Morehead State Teachers College and make their report to the Board.

Purchase of Bonds by Faculty and Staff: President Vaughan reported that all the faculty and staff of the college were purchasing war bonds in an amount not less than 10% of their salaries.




Mrs. A. W. Young, Vice Chairman: On motion duly made and seconded, Mrs. A. W. Young was reelected Vice Chairman of the Board.
