fell I thought there was three shots I thought Toliner struck

Daniel } I dont no he shot but sum body  
White witness } nooked John Day down after he commanded  
the peace as he rose I saw him with his pistol  
in his hand. I saw Tolener raise a pistol like he was  
going to hit sum body it was in rowour co on the  
first fourth day of august

boon layer } I saw John martan John peton + hew  
witness } Clark with pistols then I saw Sutton  
take John petons pistol from him. I saw martin  
+ peton start to get then I saw fox sismore  
run in + said he wouldnt waste there blood  
ne deet floyed Tolener run in with a pistol  
+ sise more caught Tolener I saw Tolener strike  
at samon but did not hit. John Day cride out  
peace next I saw John strike at sise more  
but sise more struck at John first  
ad sismore threw a rock befor any shot was

and he had no share to put any in it

When he fell had his Pistol in his hand  
Suton demanded the Peace but wanted  
to pite all the time
