Saturday Is The Day To Act

Through these columns an attempt has been made to bring before the people of Rowan County the local issues as they exist in the Senatorial Campaign. Particularly have we pointed out the importance of this campaign as regarding the Morehead State Teachers College and what it will mean towards removal of a man as President of the College who is not capable of heading that great institution which is the life of Morehead and Rowan County.

We have repeatedly pointed out the mistakes that have been made. We have, without contradiction, shown the people where thousands of dollars of the taxpayers money is being squandered through graft and politics. We have shown where Clarke Lane, the campaign manager for Governor Chandler in Rowan County is receiving and has received for many months \$100 a month without doing one bit of work. Clark nor anyone else connected with the Chandler organization has denied this. We would not have printed the facts about the well paid and well pensioned campaign manager unless we had first investigated and known what we were saying was a fact. We ask Clark Lane to stand before the people and deny this charge. He has had his chance when he had the platform here when Governor Chandler spoke, but not one word fell from his lips about the money that he has received.

Likewise Bill Sample has never denied that he is riding the Morehead State Teachers College gravy train. He has not yet denied, for it would do him no good to make a denial, that he is getting fat sums from the taxpayers pockets. It has gone undenied and uncontradicted that \$5,000 was paid out illegally to a man that helped President Babb secure a place as head of this institution.

We have challenged and still do challenge Harvey Babb, Bill Sample or Clark Lane to deny through their newspaper or openly that the charges we have put before the people are not the absolute truth. As a matter of fact we have caught up with them and the details have been pulled and hope to pull in the future have been uncovered so that all may see them for what they are.

To Morehead this Senatorial race is as important as it is to any section of Kentucky. Morehead has a need of unfair, unethical and unclean politics in a great state institution to clean up. Morehead people have this opportunity to show that they neither wish nor desire the Morehead State Teachers College to become a political football and a gray train for those in charge. For this reason the present Senatorial campaign is important to the people here. Not only will we be helping to nominate a man that is heading an administration that has made it possible for us to live but we will be placing a stamp of distinct disapproval upon a number of political parasites.

We believe that 90 percent of the people of Morehead are in favor of a change at the Morehead State Teachers College to keep the situation from growing worse. We have attempted to impress on these people's minds that a vote for Senator Barkley is a reprimand to the people who are attempting to turn the Morehead State Teachers College into a petty political affair in order that the gray train may still run and trickle more gravy in the forms of dollars and cents down their vests.

We have mined no words nor have we omitted any names. Our fight has been an open one. The statements that we have made are not contradicted. We know that all eastern Kentucky is looking at Morehead to see what the final outcome of this unfortunate situation at the college will be.

Likewise we have pointed out that for the first time in history the appropriation of the Morehead State Teachers College is lower than Murray. No one has denied that President Babb and Governor Chandler are responsible for Morehead having an appropriation of \$120,000 less than Murray.

We have challenged anyone to point to a single square inch of road that the state administration has built in Rowan County since Chandler became Governor. That challenge has never been accepted because the people know that no roads have been built.

We have also asked the Chandler organization to point out one single thing that the present State administration has done for Rowan County and have given them the opportunity to deny (which they couldn't) that the Federal government under the leadership of President Roosevelt and Senator Barkley has done more for the people of Rowan County than has ever been one in the past.

The people of Rowan County have had ample time to weigh all that has been said. Saturday those same people are going to the polls and denounce the regime that has been set up at the Morehead State Teachers College and tell the firm of Babb, Sample and Lane that they are not wanted here.

A Side Issue That Was Over-Looked

In the Kentucky Senatorial race which now enters the home stretch with the finish line set for Saturday one important question regarding old age assistance has been overlooked in all the arguments and side issues that have been advanced.

The Federal government, in passing the old age assistance laws did not specify provision that an aged person who owned real-estate must make a deed to their property to the state of Kentucky before receiving an old-age pension. Governor Chandler and the state legislature tricked the old people again on this issue and in passing the old-age assistance plan in Kentucky a provision requiring a deed to this property was required.

Naturally Governor Chandler leaves this out of his speeches. In fact the Governor would prefer not to mention old-age pensions because everytime he does he has to make weak excuses which are followed by vigorous and matter-of-fact arguments from Senator Barkley that cannot be denied.

The old people of Kentucky have not been fooled in the matter. They know that President Roosevelt and Senator Barkley worked for a \$30 a month old age pension with the Federal government putting up one-half of the money and that Chandler passed a pension bill that averages but slightly over \$9 a month. They know also that only one other state, Mississippi pays a lower pension than Kentucky.

Barkley's magnificent majority which he is expected to receive Saturday will be due in a large part to the support of the old and reserve citizens of Kentucky.

Preserving The C. C. C. Camp

Until the administration of President Franklin D. Roosevelt came into power in the Federal government the establishment and maintenance of Civilian Conservation Camps throughout the United States was practically unreamed of.

With the C. C. C. camps in their sixth year there can be no one who can conscientiously deny that the plan has been a forward step in this country and there seems no question but the public, seeing the many and far-reaching benefits of these camps, is in accord that they should be maintained. However, unfortunately with every other constructive measure that has been put forth by the successful Roosevelt administration there is a group of Republican politicians and Democratic Liberty Leaguers who are against every accomplishment of the present administration.

All of which brings us closer to home inasmuch as we have a CCC camp located at Rodburn, one mile east of Morehead. Some five months ago word was received here that the Rodburn camp would be abolished. A group of leading business men and community leaders met at the city hall to form a union to use every legitimate effort to keep the camp at Rodburn. Democrats and Republicans, all interested in Morehead and Rowan County attended that meeting.

It is recalled that Alben W. Barkley was contacted by telephone that night. He promised the gathering that he would do everything in his power to keep the camp for Morehead and Rowan County. It was he who steered the bill through the Senate increasing the appropriation for the Civilian Conservation Camps and it was President Roosevelt who signed this measure into law. The Rodburn CCC camp was not abolished and stands today.

The great benefits that are derived from the Rodburn camp may be found in an accurate report compiled and published at that time. Listing the fires that had been extinguished the report stated as follows:

The Rodburn CCC camp successfully extinguished 251 forest fires in Rowan, Bath, Menifee and Morgan Counties during its first year of operation.

For many years fire had been allowed to run rampant through the forests of this section of Kentucky. Residents of Morehead recall that practically every spring and fall the town was almost completely encircled by a wall of fire. Unfortunately, the people in this section at that time were not conscious of the value of protecting the forest and timber.

In addition to combating fires, building roads, trails, bridges and towers the CCC camp brought to the people the realization that our forests should be protected. Farmers became more careful in starting fires or burning off wood piles. Hunters were warned and apparently have been heedful in refraining against starting fires. In brief, it was a fruitful educational plan on assisting in the preservation of our forest.

During the year 1937 there were reported 23 fires in this area which burned 610 acres. From January 1, 1938 to April 1, 1938 twelve fires have been reported. One hundred and eighty-nine acres have been burned during these 3 months. However, only 61 acres of this amount was on government property.

The four counties that are completely served by this CCC camp have a total area of 281,507 miles in forest or an average of 39.6 percent. Parts of Elliott and Fleming County are also served by this camp. The population of this area exceeds 50,000.

Including the parts of Fleming County and Elliott County that come under the supervision, so far as extinguishing forest fires is concerned, it is seen that this CCC camp supervises 281,507 acres of land that would, if properly protected from fire, produce clear hardwood.

Figuring conservatively, this CCC camp has saved at least 70,000 acres of privately owned forest land and an equal amount of government owned land would be burned each year. Figures are not available as to the loss in dollars and cents that would result, but it is apparent that there can be no hope to secure a stand of timber in this area unless it is given protection.

This CCC camp has constructed 35 miles of hard-surfaced roads. They have put up 40 miles of telephone wire. The roads that have been constructed have been of inestimable value. They have opened up parts of these counties that previously had been inaccessible except by horse-back. This camp has 12 telephone stations, located at strategic points, for reporting fires. Three large towers that no doubt cost a considerable amount of money have been built overlooking many miles of this area.

Three bridges have been constructed. Travel previously was impossible until these bridges were put in. Now these roads can be travelled the entire year.

The people in this section are hard-working and poor people that are deserving of assistance. They live on poor farms classified mainly by the United States Department of Agriculture as "substance farms." Many try to grow timber and corn on the same land. It is not unusual for a man to spend a day working in corn fields for each bushel of corn obtained. These people are fighting hard to keep off the red dirt rolls.

This forest area is fast becoming a mecca for tourists. Its scenery is almost unmatchable. It is estimated that several hundred tourists and tourists have visited this forest area. The record book in the fire tower at Morehead show visitors from every state in the Union and many foreign countries. The more tourists attracted the more these people are helped by the money they spend.

This area was at one time a great hardwood forest lumbering center. The timber has been largely cut and little lumbering is going on at present. The people, however, are here. If the hills can be restored to timber, labor can be had for years to come when the boys reach mature age. Under the direction of the forestry department this lumbering can become prepetual.

This is written to more fully acquaint the people of the great advantages that this camp has brought to the people of Rowan County. We owe a debt of gratitude to President Roosevelt and Senator Barkley for the establishment and maintenance of this camp. In preserving this C. C. C. camp alone Senator Barkley has done more for Rowan County than the present state administration has done at any time since it took charge.

Saturday is the day when we can go to our polling places and show our appreciation of this and a thousand other commendable things that the New Deal has done for the farmers and poor people of Rowan county by placing an 'X' after the name of Alben Barkley, the President's right-hand man.

The Issue Is Easy To Understand

The two issues in the Kentucky Senatorial race are easy to understand and when voters go into the polls Saturday to cast their ballots there should be little difficulty in making a choice between the two candidates.

The issues are:
Do you believe in President Roosevelt and the great work he is doing and has done for the average man of the nation and this state? If you do you should vote for Senator Barkley. If you are against President Roosevelt and do not approve of the Works Progress Administration and the thousands of other things which he has done for the peo-

ple of Rowan County... If you are against that... then you should vote for Chandler.

The second issue is:
Do you believe that Senator Barkley has made us a good Senator? Do you believe that Chandler would ever reach the high place that Senator Barkley has achieved in this nation? If you believe that Senator Barkley has represented our State well and brought honor and credit to the Commonwealth of Kentucky then you should re-elect him.

Those Democratic voters, are the real issues in this campaign. A vote for Chandler is unquestionably and undeniably a ballot for the Republican party. As Senator Barkley said in his speech here last week "The American Liberty League and Republican politicians (not the kind of Republicans who have the welfare of the people at heart but who hate Roosevelt will hold a holiday if Senator Barkley is defeated.

So far as the state of Kentucky is concerned, we have never had a man at Washington who has reflected more credit of the state than Senator Barkley has. He was twice key-note of the national Democratic convention, an honor never before held by any man; in addition he is the first Kentuckian to be floor-leader in the United States Senate.

There seems little doubt but that Governor Chandler is a Democrat actually running his campaign largely on money donated by Wall Street and Republican leaders.

Democrats of Rowan County and Kentucky: Is our party and our State up for sale to the Liberty League, Wall Street and the Republican politicians? The ballot box Saturday will answer that question.

crease the loan basis of certificates and later helped pass that measure over the veto of President Hoover.

Sponsored First Bonus Bill
Barkley introduced the original bill for the cash payment of bonus certificates, had a prominent part in drafting and putting through the final legislation and voted to re-approve this act that measure.

This act placed nearly \$2,000,000 in the pockets of ex-servicemen three years ago—a time when tens of thousands were jobless and desperately in need of a helping hand.

In Kentucky, 62,945 veterans were enabled to cash certificates with a face value of \$98,288,371.

In his long service Barkley introduced and secured the adoption of thousands of special acts for veterans of all wars. He has personally taken up with the Veterans' Bureau and War Risk Bureau thousands of individual cases in his efforts to secure just compensation for ex-servicemen.

Always Friend In Need
The Senator has never hesitated to raise his voice when the veteran needed a friend or defender.

To a Senatorial critic who complained that veterans' relief particularly the cashing of bonus certificates, was imposing a heavy burden on the Treasury and prevented the government from balancing the budget, Barkley made this crushing rejoinder:

"I wish some of those who make that claim would get a look at the budget of some of these poor disabled soldiers who are being neglected and ignored, many of whom have had their compensation discontinued without even the courtesy of a final giving the reason.

"This is a fair, safe and sound method by which this obligation to the veterans may be discharged, even though the discharge comes nine years prior to the term fixed in the bond which the government executed without consulting the wishes of veterans."

Relief for Disabled
In a speech urging liberation of legislation providing relief for disabled war veterans, the Senator said:

"Those who think they will be able to mollify or satisfy the disabled veterans, with a pittance of \$12 a month and a maximum of \$40 a month for total disability are reckoning without their best friend."

"We expect a veteran to be grateful for that slight grant, when his wife may be without decent garments for his children, may be hungry or being cared for by charity? I repeat, those who anticipate such result are going to be disappointed."

THE SUNDAY SCHOOL LESSON

Written Each Week By E. H. KAZEE Pastor Of The Baptist Church SUBJECT: RUTH-ADVENTURER OUS FAITH. (Read the Book of Ruth) Golden Text: "Thy people shall be my people, and thy God my God." Ruth 1:16. The story of Ruth the Moabitess is essentially a story of adventurous faith. She stood one day at the cross-roads of life and made a significant decision, one that changed forever the course of her life. She chose to turn her back upon her native Moab and her native religion and to follow her mother-in-law Naomi to another country and another religion. This decision was exceedingly difficult and could not have been made by one not having a great and adventurous faith. It involved the dissolution of national and racial bonds. Ruth well knew the ill feeling that existed between her own people and the people with whom she was about to cast her lot. Moreover, Naomi

had made it quite clear that a Moabitess would not be welcomed on Hebrew soil. To choose Judah for a home would increase the stigma of being looked upon as a hated foreigner. The choice also involved the acceptance of the Hebrew God and the rejection of her Moabitic god or gods. Then there was the entire problem of the uncertainty of life in a new and foreign land. Would she ever be able to establish herself as a citizen or even be able to support herself? How could she bear the racial snobishness and ill will that she was sure to encounter? These were real problems that Ruth faced that day on the desert sands as she looked first in the direction of Judah and then back in the direction of her Moabitic home. Her sister Orpha had already decided in favor of Moab, and was already beginning the homeward journey. Ruth had to decide—should she leave this, or to return from following after these, for whether thou goest, I will go; and where thou lodgest, I will lodge; thy people shall be my people, and thy God my God: where thou diest, I will die, and there will I be buried: The Lord do so to me, and more also, if I should not do these things. Naomi, of course, but it was more than loyalty to a person; it was loyalty to Naomi's God. It was more than loyalty; it was adventurous faith.

Perhaps there are those reading these lines who like Ruth are standing at the parting of the ways. The life of sin, of unbelief in God, is calling to them to continue in it. They have ties and habits which they find it hard to break. They have associates who tempt them to remain in it. But they have also heard the call of God through His Word and the convicting power of the Holy Spirit to give up the old life to Jesus to save. Shall they turn to Moab and their old habits, gods or shall they turn to the true God, Jesus Christ? May faith and follow wherever God leads!

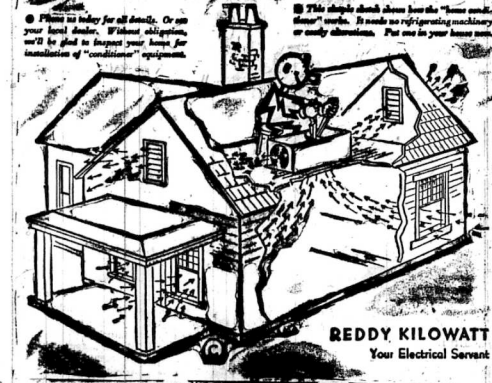

The following is the statement of Governor Chandler concerning his illness. This was taken from the Courier-Journal of the issue of July 23, on the day he became ill. Later the governor and his doctors stated that he had been poisoned by drinking poisoned water.

He disclosed that the gastric disturbance in his lower abdomen was a recurrence of a disorder contracted a year ago in Biloxi, Miss., when he, Mrs. Chandler and J. "I have been suffering for several days," the Governor said. "Many times when I was making six or eight speeches a day and shaking hands with everybody and wanted to shake hands with me, I was in severe pain, but they didn't know it."

ago. The Governor still was opposed to paying the old people \$30 a month, and again he went on the floor of the Legislature to fight the plan. He beat it again.

"Of course if he is elected he will continue to represent the old people who do not believe in paying. He will continue to fight against the old people, and because he is unable to wipe the pension out entirely, he does the best he can to hold the payments to pitiful sums.

"If he could get in the Senate he would vote to end the pension payments. If he failed in that he would vote to decrease the payments. That's what he has done in Kentucky. The old people will not be fooled. They know that if they ever get in Kentucky what old people get in Indiana, Illinois and Tennessee, they must not let Chandler get in the Senate. He has been their foe from the beginning."

In the rural counties Mr. Barkley stressed the aid farmers had received from the Federal Government. He deflected the tobacco marketing plan which the farmers have approved. He said it had been approved by some men who grow thousands of acres, and by the tobacco companies, who always are against any marketing plan which assured the farmer of better prices.

Mr. Barkley charged that these men are behind the Governor's candidacy, and that if Governor Chandler is elected he will vote in Washington so the tobacco companies can buy the Kentucky crop at their own prices.
