COMMENCEMENT

1913

EXERCISES.

The Commencement Exercises of the Normal School were held this week. The Baccalaureate Sermon was delivered at the Christian church Sunday morning by Rev. F. C. Button. Monday night a recital was given by the Department of Music. Tuesday night an operetta was given under the management of Miss Annie Tibbott, teacher in music. Wednesday at two o'clock Class Day exercises were held. Thursday morning at ten o'clock Commencement exercises occurred on the Campus. The following were the graduates: Bennie Sweet, Fred Cook, Mahala Scaggs and Bertha Shepherd. There were also four graduates in music. The Class address was given Thursday by Prof. A. W. Fortune, of Transylvania University, of Lexington, Ky. Thursday evening the Alumni Banquet was given.

The school closes its twenty-sixth year with more flattering prospects than ever before. Since January first of this year it has made a phenomenal gain in strength and progress and influence in this community. The faculty is made up of capable, conscientious, christian men and women, of whose faithful efforts too much cannot be said in commendation. President J. Wesley Hatcher, Prof. D. M. Holbrook, Prof. R. M. Deskins, Miss Anna Tibbott, Miss Cromwell, Miss Plummer, Mrs. G. C. Nickell, Miss Jamison, Dr. and Mrs. Thomas have all contributed their best efforts toward making the school successful. But, the great strides which have been made during the term that is closing are due mainly to the fact that it has at its head a man who possesses all the qualities necessary to make such an institution a success. When Mr.

Hatcher came to Morehead he was met by the people of the community, who knew him well, with cordiality and complete confidence. Every act and effort of Mr. Hatcher's since he took charge of the school has more than justified that belief. He and his able faculty have achieved mightily in these few months. They have accomplished results which even the most hopeful had not expected. During this term 291 students have been enrolled, notwithstanding the fact that there is one public and one private school in the town besides. The intellectual and moral standards of the school have been perceptibly elevated, and already his influence for righteous living and high thinking is being felt in the school and community. President Hatcher has been compelled to give much time to familiarizing himself with conditions surrounding the school. Judging from the masterly way in which he has acquainted himself with and handled the situation, the next session will record a degree of prosperity and efficiency greater than ever known. It is safe to predict that all who go forth during his incumbency as graduates from the school will bear the stamp of high character and thorough scholarship.

The term which is closing has been characterized indeed by a strenuous and heroic effort, and each and every citizen should seek the opportunity to express to the faculty the approval and the gratitude which they so sincerely cherish, and to pledge themselves to any new plans or adjustments which may be attempted for the welfare of the institution in the future.

Oct. 3, 1913.

A faculty meeting was held at 3:30 P.M. in the library of Burgess Hall, object the signing of certain diplomas which had not been received in time in May, and the election of a Secretary. Miss Cromwell was chosen. The time was devoted chiefly to the discussion of the introduction of tennis and basket ball. Miss Jones was made supervisor of athletics. Carried. Moved that the faculty and students secure the amount needed for these games by soliciting from friends. Carried. After some discussion of the order in which pupils should be required to enter and leave the school building the meeting adjourned.

This matter having been disposed of, the faculty was asked to consider the behavior of Troy Denslow, a scholarship pupil. Mr. Hatch stated that he had been guilty of insubordination, of using bad language, and especially on one occasion of creating a disturbance in the dormitory. Troy was called in and given an opportunity to explain his conduct, if he had any thing to offer by way of extenuation.

Motion was made that he be given another

trial; be retained in school on condition of good behavior and loyalty to the school. Carried

He was queried, and there followed a long and earnest discussion of the matter. No decision was reached, and the meeting adjourned until the next day.
