- Permanent positions have been frozen other than critical hires because of the unknown factors that may impact the institution.
- Hal Rogers and the NASA leaders along with the Lt. Governor were on campus Sept. 20 for a special meeting regarding grants for the Earth Space Science Center.
- Retention is an emphasis right now.
- Winter session possibly expanding to include repeater courses.
- More ways to offer 4-week courses in the summer are being discussed.
- Enrollment is still being evaluated for Fall 2017.
- FUSE has been hired to help market our graduate programs.
- Credit hours taught by staff will be counted under performance-based funding.
