SUPREME COURT JUSTICES IN OFFICIAL PORTRAIT

THIS IS THE FIRST official photo of members of the United States Supreme Court since the death of former Chief Justice Fred M. Vinson. Trust Certificates Held Subject To Tax

The State Department of Revenue now has the right to tax build-up trust certificates, owned by individuals, as a result of a Court of Appeals decision. The certificates were issued by the State of Kentucky, on the basis of a decision of the late Ernest A. Jackson, Lexington, that the certificates were "real estate" located elsewhere and therefore not subject to Kentucky taxation. Kentucky Must Get More Money To Keep Assistance At Present Levels

Kentucky may have to find up to \$160,000 a year in new revenue to keep the Public Assistance program at its current level, since the State's so-called "lien" may be cut by the coming session of the legislature.

This warning was made today by the Public Assistance Committee of the Kentucky Security Vege E. Barnes, who said he understood there would be more pressure on the General Assembly to repeal the statute enacted in 1952.

Since the law went into effect, the average of payments made to Old Age Assistance recipients has gone steadily upward and the law has been one of the main reasons, Barnes said.

He estimated that it would take \$160,000 extra a year out of state funds and an additional \$100,000 in federal funds to maintain the new averages if the law were to be repealed—and that the figure may be even higher in years to come.

A&ID Board Lists Industrial Sites In Morehead And County; Labor Supply 1,500 To 1,900

Morehead and Rowan County contain several industrial sites adjacent to highway and rail facilities, according to a report issued today by the Agricultural Development Board and the Morehead Board of Trade.

The area's mineral resources include fire clay, building stones—both limestone and sandstone—and gravel, mark, common clays and shales, the report disclosed.

The report described the mineral deposits thus:

Fire Clays: Large amounts of high grade fire clays are available for manufacture of refractories and are used to a considerable extent for this purpose.

Building stones: Sandstones of superior quality for building purposes are produced in considerable quantities. Limestones, suitable both as building and agricultural purposes, in addition to high calcium limestones are present.

Large marl deposits are available for fertilizers, in addition to creek sands and gravels for building purposes.

Clays and clay shales, suitable for manufacture of bricks and tiles, are also present.

The Morehead labor area—including Rowan, Bath, Fleming, Carter, Morgan and Elliott counties—could supply about 3,300 men and 4,500 women, for industrial jobs with some 600 men and 500 women of them from Rowan County.

"If attractive jobs were offered in Morehead, a labor supply of 1,900 men and 1,900 women could be expected for employment in that city," the report added.

Farm Support Program, Which Can Be Adjusted, Urgent Need Says Secretary Of Agriculture

Any effective solution of today's farm problem must provide methods for reducing our huge stockpile of agricultural commodities and at the same time prevent further burdensome accumulations.

Getting rid of these surpluses is only half of our problem. Even if we were able to bring them down to manageable proportions, we would soon acquire new hoards of wheat, corn, cotton and butter under the existing system of price supports.

We already have approximately \$2.5 billions tied up in loans on
