- Announcements
 - Dr. Alison Hruby, FCTL—Peter Felton, Elon University Tuesday April 4 @ 3:30pm in ADUC Ballrooms A & B
 - Provost replacement updates A vetting committee has been appointed to chose an interim Provost.
 - Faculty Regent Election advice for future elections There was direct electioneering from
 Administration for certain Faculty Regent candidates. This should not happen in the future.
 - Administrative censorship Bernadette Barton wrote a Hinkle Grant to bring in the author of White Christian Privilege. There were student complaints about the subject along with other issues regarding sponsors, public and anonymous. These issues resulted in the talk being cancelled. Students have also been offered payment to audio/video tape liberal professors to reveal a woke bias. We just need to be aware of these issues and to what degree our free speech is being chilled by what is happening in the general assembly.
 - Regent Adams There is a PG as we as a statute that protects faculty and student free speech. Some of the issues stem from administration.
 - Resolution by Senator Strivers impact on MSU? This resolution proposed a new public institution in southeast Kentucky. It could be corrosive to MSU student numbers.
 - College of Science and Caudill College re-organization? Regent Adams spoke on Caudill College. There was a proposed model with three departments and then one keeping one school in the same place and figuring out later what was going on with the school.
 - Senator White Their department chair cannot provide information on reorganization.
 They have a faculty meeting next week and hope the dean will be able to provide more information.

FWC Action Items

- Policy revision document The document is accepted, but the admin does not want to post it on the web site. – It is not clear why they do not want to post it, just that they want to keep it simple.
 - Regent Adams thinks a resolution should be done.
 - Senator Brigham If we do not do the resolution today, is there time to do it in April? Senator Chatham advised there is time.
 - Senator Taylor We want an electronic trail for this document so we can find it in the future because documents seem to mysteriously disappear. It needs to be posted where the polices are posted because that is where it makes the most sense.
 - Provost Norman wanted to know if it could be posted where you would have to log in to see it so the general public does not see it.
 - Senator Chatham How long is the resolution? Senator
 Himes It is short. It says what it is and what we want done with it. Senator Himes read the proposed resolution.
 - Senator Morrison thinks we should get it on the docket and revise as needed at the next meeting.
 - Senator Lennex This is a first reading. Senator Morrison proposed it, Senator Lennex is seconding. Senator Chatham believes it is order for a first reading and thus there should be no debate. The debate would be at the next meeting. All in favor to accept as first reading, no one opposed or abstained; passed.
- UAR136 Still working on this. The key changes include:
 - Updates for online exams
 - Updates for changes to teaching types and modes
- PAc-29 workload table Senator Kessinger gave history of the table that was created by his sub-committee. It is posted on Blackboard. Please review and send feedback.
- o Governance Senator Lennex, Senator Kessinger reporting
 - List of committee assignments Available in Blackboard. Made up of people who indicated their willingness to serve on a particular committee. No one is serving on more than two committees. There are no conflicts with college tenure committees. Senator Kessinger made a motion for a vote. Senator Stubbs seconded. There was no discussion. All in favor, no one opposed; Approved. The individual will be notified by the end of the weekend.
 - Election Faculty Rights and Responsibility At-Large Candidate Dr. Suzi White or Dr. Ignacio Birriel a vote was posted in the chat. Dr. Ignacio Birriel took the vote, 53.85% to 46.15% and will be the new at-large representative on the FRR committee.
 - Shared Governance Award Nominations have not been received. You have until April 6 @ 3pm to make nominations.

New business

Attacks on LGBTQ+ students via legislature – Regent Adams pointed out that the bill does

not specify ages, it only says students, so it makes some texts currently being used at college level, illegal. Senator Lennex believes we need to support free choice of children and their families. Senator Taylor thinks faculty should put pronouns on signature line because that is code for "I'm an accepting person". Secondly, we have minors in university classes via Craft Academy. We need guidance on what can be legally taught in these classes. Senator Lennex agrees that we need guidance. The guidance should be made hand in hand with Faculty Senate, Staff Congress, and SGA.
