- Call to order @ 3:45pm
- Approval of March 30 minutes Motion to approve Senator Eisenhour; Seconded by Senator Brock; All in favor; no one opposed; Approved
- Announcements
 - o Provost replacement updates Candidate, Dr. Raj Parikh, visiting on Tuesday. Four faculty members will be part of the committee: Dr. Cudd, Dr. Kiffmeyer, Dr. Jenab, Dr. Kaufman
 - College of Science and Caudill College Re-organization updates No additional details available at this time.
 - Proposed department sizes across campus Proposed to be around 20 employees
- President's report Not present, no report
- Provost's report Not present, President Long reporting
 - Policy changes need to be fully vetted and approved by May 1 in order to be included in the Board of Regents' June 15 meeting for implementation next year.
 - PAc17 should be wrapped up soon.
- Faculty Regent's report Regent Adams
 - Link to legislature resolution placed in chat: (https://apps.legislature.ky.gov/recorddocuments/bill/23RS/sjr98/orig_bill.pdf). Regent Adams went over the resolution. There were three areas that were to be studied. First, CPE was supposed to look at government structure. Secondly, should there be a new university in southeastern Kentucky, and lastly, the function of KCTCS. The President addressed this at the last BoR meeting; however, the BoR has never received the actual resolution. President Morgan said the legislature is somewhat upset with fiscal management. He feels there is poor fiscal governance but stated that our BoR has done a good job in this area. President Morgan said the issues with southeastern Kentucky are not necessarily a reflection on MSU. This information was shared in an open session. These items don't seem to be an accurate overview of the resolution. A new school will negatively impact MSU. Duplication of programs has not been addressed.
 - President Morgan thinks 20 employees per supervisor is a good model. He also thinks the colleges are unevenly apportioned. He wants to see evening out on a spreadsheet. Every college will be affected.
 - Senator Chatham Has CPE said how they are conducting their study, where will
 they get the information for their study? Regent Adams has asked but has not

- been answered. CFO Fister-Tucker said that CPE has hired an outside body to make that study.
- Senator Stubbs There are several small departments on campus, are we combining them into one and, if so, what happens to FEPs, evaluations, etc., especially those going up for tenure? Regent Adams In an on-campus meeting, Dean Henneberg said the President seemed to think that 20 would be a good number. Regent Adams got the sense that they were referring to the number of persons in the department, so it could be instructors and not necessarily tenure lines. How it affects FEPs has not been addressed.

 - Academic Issues Senator Chatham
 - Gen Ed Council report Met Tuesday at 9am via WebEx.
 - Work continues on website Those in charge of the website feel the he forward facing website should only be for students with links for faculty resources.
 - New UAR for the Gen Ed policy This was the first time most of the policy work group had seen the draft. Course proposals would be treated similarly to curriculum proposals; the Gen Ed Council would be acting as a curriculum committee for Gen ed courses. More series proposals can be brought to the Gen Ed Council by any member. The BoR should not be a step in the process and faculty should be. Once Senator Chatham has a copy it will be forwarded to Faculty Senate and the Academic Issues Committee.
 - Regent Adams suggested Faculty Senate define who faculty is.
 - Senator Lennex agrees with Regent Adams. What defines who is faculty needs to be clearly outlined.
 - Senator Hare added the only place he knows of where the role of who is faculty, who votes for Faculty Senate is written down is in the constitution of Faculty Senate. In PAc1, there are descriptions of all the academic titles. However, it doesn't talk about the specific roles in terms of voting in Faculty Senate or participation in curriculum. Any change to clarify would most likely need to be added to the constitution for Faculty Senate.
 - Evaluation Senator Stubbs
 - Approval of Dean Evaluation, 2nd reading No friendly amendments were received. Wants to move document forward. Senator Chatham moved to approve second reading. Seconded by Senator Prindle. There was no discussion. All in favor; no one opposed or abstained; approved

- PAc-29 workload table. Please provide feedback. The Provost desires quick action to facilitate FTE calculations. Senator Kessinger asked if formulas had been sent out to the education department. Senator Hare said FS Senators are expected to do that part and should do so ASAP. A copy of the formula is in Blackboard under the March 30th meeting.
