Dr. John Nelson is chairing the search for the new dean of the Caudill College. The committee is scheduling the on-campus visits. The on-campus visits for the Associate Provost are also complete.

Dr. Schroeder provided some additional information on the reorganization. The psychology department is still trying to be homed within the college of science. The college of business is in a similar state of unknown future direction at this time. Senator Lennex asked if the two departments would be combined into a single department. Dr. Schroeder was unsure of the final details. Senator Lennex followed up by asking if there would still be an Associate Dean if there were still two departments. Dr. Schroeder said he was not sure at this time. Senator Lennex asked which faculty from HPIL are being discussed to be moved to business and why? His response was Political Science and Legal Studies.

Senator Adams asked for clarification on the Caudill College Dean search. She said two people have not heard from the search committee since Christmas. Dr. Schroeder reported that Dr. Nelson said they would have the on-campus schedules shortly. Senator Adams also raised a concern about the clarity of the weather policies (Plans A, B, C, & D). Dr. Schroeder clarified each of the plans.
