The Board of Regents of the Morehead State Normal School and Teachers College met in the office of the State Superintendent at Frankfort, December 21st, 1927. Those present were:

The Board adjourned to the Senate Chamber at 10:00 A. M. to receive bids for the combined auditorium and gymnasium building and a president's residence, to be erected in Morehead, and the following bids were received, opened and read:

The bids call for the removal of the three buildings on the ground, in the contract.

After the reading of the bids, the Board returned to the office of Superintendent Rhoads, and continued its meeting.

The following motion made by Judge Senff, and seconded by Mr. Perry, was unanimously adopted:

It appearing that the bids of Thomas Ashpaw of Portsmouth, Ohio, and Dana H. Capappealer of the same city arrived after the hour designated, and after the Board had opened and read all of the other bids received, the Chairman of the Board is directed to return such bids, unopened, with a suitable explanation.

On motion of Judge Senff, seconded by Perry, and unanimously carried, the following resolution was passed:

That the bids as mentioned above are to be held over, and action thereon deferred until the next meeting of the Board, which is to be held in Morehead December 28th, at 10:00 o'clock A. M.

It was moved by Judge Senff and seconded by Mr. Perry that President Button be authorized to submit a list of books to be purchased for the Morehead State Normal School and Teachers College library. Motion carried unanimously.

The following motion was made by Judge Senff and seconded by Mr. Perry. Unanimously carried:

That President Button be authorized to employ such emergency teachers as may be necessary for the second semester, and that the President be authorized to make a separation between the college and normal school department, at such time and in such manner as he may think best, in order to meet the requirements of the Southern Conference of secondary schools and colleges.

On motion of Judge Senff, seconded by Mr. Perry, and all members voting aye, the following resolution was passed:

It appearing that at the meeting of the Regents, held in Louisville, ( ), that the President was authorized to sign checks for the school, in lieu of the then business agent, who was given a leave of absence by the Board, and that the minutes of such meeting, stating its said action have been lost or misplaced, and are not a part of the minutes of the Board, such action and authority to the President is now given nunc pro tunc.

On motion of Perry, seconded by Senff, authority is given President Button to buy necessary cabinets to house apparatus in the science department.

It was moved by Senff, and seconded by Perry that on the recommendation of President Button, Professor M. J. Clarke, formerly of Anchorage, Kentucky, be employed as assistant professor in the science department, at a salary of \$200.00 a month for five months. Motion carried unanimously.

On motion of Perry, seconded by Senff, the Board adjourned to meet December 28th, 1927, at Morehead, Kentucky.
