At a meeting of the Board of Regents of the Morehead State Normal School and Teachers College, held in the office of President Button, Morehead, Kentucky, Thursday, at ten o'clock A. M., the following members were present:

Mrs. S. M. Bradley, newly-appointed member of the Board appeared, and the oath of office as such was administered to her. Oath was also administered to Judge Young, who was recently re-appointed to the Board. The oaths were administered by Miss Anna B. Carter, Notary Public Rowan County, Kentucky.

It was moved by Judge Young that Mrs. Bradley be made Vice-chairman of the Board of Regents. Seconded by Mr. Senff. Unanimously adopted.

Moved by Judge Young that Judge Senff be made secretary of the Board of Regents. Seconded by Mr. Perry. Unanimously carried.

Minutes of the meeting held February 6th were read and approved. Also, the minutes of the meeting held February 17th were read and approved.

Moved by Judge Senff that the bid of the Electric Wiring and Contracting Company for the Underground wiring be accepted. Seconded by Perry. The roll call upon this motion stood as follows:

It was moved by Judge Young that as there are now two negro women rooming in Allie Young Hall, that they be immediately removed from that ahhh, and that no negroes shall be permitted to room in any of the dormitories of this institution. The president is requested to get cooks to take the place of the two women referred to. Seconded by Mr. Perry. Unanimously adopted.

Moved by Judge Senff that the communication from Mr. J. T. Jennings be taken under advisement. Seconded by Mr. Perry, and unanimously adopted.

Moved by Judge Young, seconded by Mr. Perry, and unanimously carried that the salary of Dr. G. C. Nickell as school physician be fixed at \$200.00 per month, to so remain until the further order of the Board.

Moved by Judge Young that the names of all persons granted scholarships in this institution shall be submitted to the Board of Regents, with the exception that each member of the Board, including the Chairman, shall have the right to designate one worthy person to a scholarship. Seconded by Judge Senff. Unanimously adopted.

Moved by Judge Senff that Judge Young and Mrs. Bradley be appointed a committee to secure options upon any suitable location or locations available for the location of a training school. Seconded by Perry. Unanimously adopted.

Moved by Judge Senff that the present salary schedule for the faculty and employes, except when changed by resolution heretofore made by the Board be continued as they now are. Seconded by Mr. Perry. Vote upon this motion stood as follows:

Moved by Judge Young that the president be requested to negotiate with proper persons to fill places of those who were not re-elected and submit their names at the next meeting of the Board. Seconded by Mr. Perry. Unanimously adopted.

Moved by Judge Young that the matter of teachers rooming in the dormitories be taken under advisement until the next meeting. Seconded by Mr. Perry. Unanimously adopted.

Moved by Judge Senff, seconded and unanimously carried that we adjourn, to meet in the Administration Building, Morehead, July 25th, at 10:00 A. M.
